ON 01/23/2018, I RESPONDED TO THE LOBBY OF BCSO IN REFERENCE TO A THEFT THAT OCCURRED AT THE RESIDENCE OF ██████████

ONCE I ARRIVED, I MADE CONTACT WITH THE COMPLAINANT, MR. ██████████. MR. ██████████ STATED THAT HIS CAMERA WAS STOLEN OFF OF HIS PROPERTY ON 01/23/2018, BETWEEN THE HOURS OF 12:00 AND 17:00. HE IDENTIFIED THE CAMERA AS A MULTICOLORED "STEALTH GAME CAMERA" THAT WAS SITTING ON A SMALL TRIPOD, LOCATED IN THE BUSHES ON HIS PROPERTY. HE ALSO ADVISED THAT THE CAMERA HAS A VALUE OF \$80.00.

THE PROPERTY WAS NOT ENTERED INTO GCIC BECAUSE MR. ██████████ COULD NOT PROVIDE THE SERIAL NUMBER, NOR THE MODEL NUMBER OF THE STEALTH CAMERA AT THE TIME. HE WAS ADVISED TO CONTACT BCSO WHEN HE IS ABLE TO RETRIEVE THE INFORMATION.
