On January 29th of 2018 I called to talk to Chief Meyer. I asked him to come by our home at [REDACTED]. When Chief Meyer arrived he stated to me that he was going to record our conversation for the record. I told him that it was fine. He started our conversation by saying that I did not know the whole story, so I asked him to tell me the whole story. He told me that we had been recording our next door neighbor's house with the camera that was on a tree on this property which he stated was supposedly owned by someone else in Illinois. He said that he knew about the camera and he had a camera and camera SD card in his possession as well at the Brooklet police department. He stated that the camera was found by some children, and that it was "just on the ground." The pictures were looked at and nothing was being done, per his report. I told him that the camera was mine and that the tree and the property in question was also mine. I told him that I had a copy of the property lines that was provided to us when we purchased our home if he wanted to see them to confirm our property lines; he verbally declined. He told me that my property (camera and card) would be returned to me, and it still has not been returned to this date. I told him that a second camera had been taken as well and I told him that the reason that I called him was so that I could report two more crimes that had occurred as well. I told him (Meyer) that I had put a cable lock on a third camera that was on the tree, and that I observed a white male in a [REDACTED] cab drive up to the tree and he subsequently tried to pull the camera off of the tree (on our property). He was able to take the SD card out of the camera. I told him (Previous Chief Meyer) that when I went outside to stop him, that he saw me and jumped into his truck and drove off. I also told him that he wasn't aware of the whole story either (Previous Chief Meyer was not aware). I told him (Previous Chief Meyer) that the reason the cameras were in place was because we were instructed by the GBI that we needed to collect as much evidence as we could of the constant harassment that officer [REDACTED] was doing to my wife. For example, he [REDACTED] was parking in front of our house facing the back of the cul-de-sac, he would at times drive by our house in an excess of 9 times a day in a three hour period. He would follow her when she was driving. In addition, he followed her when she was out on her runs (on [REDACTED] and [REDACTED]).

My wife is scared of him. So I told the chief that officer [REDACTED] had sexually assaulted her and that he would not stop harassing her. I also told him that we had filed a police report with Statesboro police department and that it had been turned over to GBI for a further investigation. He said that it was the first time that he had heard anything about these incidences, and I told him that he was being informed of what had happened not only with the assault, but also with the theft off of our property. He stated that he was going to do an incident report. To my knowledge one was never done. He also stated that he was going to go to talk to the GBI after he left our residence.

I also told him about a note that was left in our mailbox in front of our home. It had racial slurs and rhetoric in it. I told him that the note said "GO BACK TO MEXICO"

SPIC AND TAKE YOUR FAT SPIC LUVIN WIFE WITH YOU". I told him that one of his officers had come and obtained the note and said that a report was going to be done. Again no report was ever filed. As a matter of fact officer Baker asked me in front of city hall if I thought that my wife might have put the letter in our mailbox; I told him no.

These are the facts:

A report was filed at Statesboro PD for the assault that occurred At Eastern Georgia Medical Center by officer [REDACTED]

Sheriff Brown has also been made aware of these things as well. Brooklet PD will not be called if anything happens at our home; the sheriff's office will be responding.

GBI was activated and has done an investigation on Officer [REDACTED] for the sexual assault (He was also questioned by them as well).

Property was stolen from our property and the chief had knowledge of who had committed these crimes.

A racial note was put into our mailbox, and nothing was done.

GBI did their investigation and has subsequently turned it over to the District Attorney's office.

Nearly 200 pictures were turned over to GBI as photographic evidence of officer [REDACTED] continued harassment of my wife.

Chief Meyer was aware of all these facts and he went to GBI on the same day that I talked with him (January 29th 2018) -- per his statement.

The chief never did the right thing; officer [REDACTED] hasn't done the right thing.

There is a petition that is going around to stop officer Baker from being named as chief. There has also been four different people that have known officer Baker for a very long time, and stated that he has been known to harass women.

So, I am making you aware of all of these facts and I am hoping that the right thing will finally be done. I am not a trusting person, but I am hoping that this officer will be taken off of the streets and not be allowed to continue to act the way that he has. There is clearly a history of negative behavior and we hope that he will be help accountable for his behaviors.
