NARRATIVE

ON SATURDAY, 8/11/2018, AT APPROXIMATELY 6:01p.m., I WAS DISPATCHED TO 131B ALEXANDER AVENUE IN REFERENCE TO A CHILD THAT WAS WALKING AND CRYING AND TOLD THE COMPLAINANT, A CONCERNED CITIZEN, THAT SHE WAS LOST. UPON MY ARRIVAL, I SPOKE WITH THE JUVENILE GIRL WHO TOLD ME THAT SHE WAS LOST. AFTER SPEAKING WITH SEVERAL PEOPLE IN THE NEIGHBORHOOD IN AN ATTEMPT TO FIND OUT WHO THE PARENTS OF THE CHILD WERE, MS. MELANIE CRUME ARRIVED ON SCENE. JUST PRIOR TO MS. CRUME ARRIVING ON SCENE, CONTACT WAS MADE WITH THE MOTHER, MS. ROBERTS, WHO ADVISED THAT SHE WAS ON HER WAY. WHILE SPEAKING WITH MS. CRUME, SHE TOLD ME THAT THE CHILD'S FATHER DROPPED HER OFF AT HER RESIDENCE AND APPARENTLY DID NOT LET ANYONE KNOW THAT HE WAS THERE WITH THE CHILD. WHEN MS. CRUME ASKED THE CHILD WHY HER FATHER DID NOT KNOCK ON THE DOOR, THE CHILD TOLD HER THAT HE HAD TO DO SOMETHING. ACCORDING TO MS. CRUME, SHE HAD NO KNOWLEDGE OF THE CHILD BEING BROUGHT TO HER.

ONCE MS. ROBERTS ARRIVED ON SCENE, SHE TOLD ME THAT THE CHILD WAS SUPPOSED TO BE GOING TO CHURCH. WHEN HER HUSBAND, MR. JAMIE ROBERTS, DROPPED HER OFF AT MS. CRUME'S RESIDENCE, THEY KNOCKED ON THE DOOR, BUT NO ONE ANSWERED. THEY THEN WENT TO HER GRANDMOTHER'S HOUSE, WHERE THEY KNOCKED ON THE DOOR, AND THE CHILD WALKED INSIDE OF THE RESIDENCE, SO THE FATHER, MR. ROBERTS, APPARENTLY ASSUMED THE CHILD WAS ATTENDED TO AND LEFT.

I THEN SPOKE WITH MR. ROBERTS WHO REPORTED HE ARRIVED AT MS. MELANIE'S HOUSE, KNOCKED ON THE DOOR, BUT NO ONE WAS THERE AND THEN THE CHILD WALKED INSIDE OF MS. MELANIE'S MOTHER'S HOUSE, AND HE LEFT ASSUMING THE CHILD WAS GOING TO BE TENDED TO. WHILE SPEAKING WITH MR. ROBERTS, HE MADE A STATEMENT TO THE EFFECT OF, WHERE WE WERE AT WAS NOT EVEN CLOSE TO WHERE SHE WAS SUPPOSED TO BE AT.

MR. ROBERTS WAS ISSUED A CITATION FOR RECKLESS CONDUCT, AND RELEASED TO APPEAR IN CITY COURT ON 9/18/2018 AT 2:00 p.m. THIS CASE WAS NOT REFERRED TO D.F.C.S. AS I DID NOT BELIEVE THIS TO BE A CHILD ABUSE CASE NOR DID I HAVE ANY FURTHER REASON TO BELIEVE THE CHILD'S WELL BEING WOULD BE IN FURTHER DANGER. THE CHILD WAS SAFELY RETURNED TO HER PARENTS.
