ON SUNDAY, 8/12/2018, AT APPROXIMATELY 5:50 p.m., I WAS AT ENMARKET WHEN REIDSVILLE MAYOR, S. CLIFTON APPROACHED ME WANTING TO TALK WITH ME ABOUT A CASE THAT I WORKED THE DAY BEFORE ON 8/11/2018 (CASE NUMBER 2018-8-508). MAYOR CLIFTON BEGAN BY TELLING ME THAT MS. CAROLYN, (CITY COUNCIL MEMBER MS. CAROLYN CRUME-BLACKSHEAR), CALLED HIM AND TOLD HIM ABOUT THE CASE. MAYOR CLIFTON PROCEEDED TO TELL ME THAT "MS. CAROLYN WOULD LIKE FOR THIS THING TO KINDA.... JUST..." AS HE MADE A MOTION WITH HIS HAND THAT I PERCEIVED TO BE INSINUATING THAT THEY WANTED ME TO MAKE THE CASE GO AWAY. MAYOR CLIFTON DID NOT MAKE A DIRECT STATEMENT OF SUCH TO ME. HE BEGAN TELLING ME ABOUT THE CASE AGAIN, AND THEN TOLD ME THAT THE PARENTS WERE NOT WANTING TO HAVE TO GO TO COURT DUE TO THE CHILD WANDERING OFF. I EXPLAINED TO MAYOR CLIFTON THAT IF I DID NOT DO ANYTHING, I WOULD BE PUTTING MYSELF, AND JOB AT LIABILITY DUE TO THE FACT THAT AS A POLICE OFFICER, I AM A MANDATED REPORTER. THE MAYOR THEN TOLD ME, "BEFORE YOU REPORT THAT TO ANY JUDGE, TALK TO STACEY ABOUT IT THEN" (INTERIM CHIEF STACY WILDS). MAYOR CLIFTON INFORMED ME THAT HE WOULD TELL MS. CAROLYN WHAT I TOLD HIM. BEFORE LEAVING, MAYOR CLIFTON TOLD ME THAT HE WOULD SPEAK WITH STACY IN THE MORNING. I CALLED MY SUPERVISOR, 1ST SGT B. JONES AND INFORMED HIM OF THE SITUATION, AND WAS INSTRUCTED TO FILE A REPORT. THIS INCIDENT WAS CAPTURED ON MY BODY WORN CAMERA AND IS ATTACHED TO THIS REPORT.
