




**PETITION FOR ROAD ABANDONMENT TO THE
BOARD OF COMMISSIONERS OF BULLOCH COUNTY, GEORGIA**

Each of the undersigned persons, by affixing their signatures, hereby request and petition the Board of Commissioners of Bulloch County, Georgia to take such action as is necessary to accomplish the formal abandonment and closing of a portion of **County Road Number 79, also known as Reddick Road**, being that portion beginning approximately 0.3 miles north of said road's intersection with State Route 26, also known as U.S. Highway 80, and ending approximately 0.2 miles south of said road's intersection with County Road Number 80, also known as Oglesby Pond Road. Refer to the attached map for a depiction of the portion of road to be closed.

The undersigned are also advised that if this portion of road is abandoned by the Bulloch County Board of Commissioners, the County will cease to perform maintenance on said portion of road including but not limited to grading, ditch maintenance, clearing of trees/debris from roadway, and maintenance of signs. Other activities that may possibly be affected by the County's abandonment of said road may include response time by emergency services, school bus routing, and mail delivery.

Reason for road closing: _____

1. Vehicles with loud mufflers from other communities keep residents awake at night.
2. Reckless and speeding vehicles put everyone at risk. Exhibit A done night of May 10, 2019.
3. Vehicles use Reddick Road to avoid routine traffic checks when set up on Highway 80 and Pleasant Hill Road.
