
1. Pay off Toombs County High School-\$4.3 Million

This would give us approx. \$5.5 Million of Bonds to be able to complete projects

- 2. Athletic Facility (Baseball, Softball, Track, Practice Field for Football & Soccer) \$2,750,000
- 3. Toombs Central (Front Owning, extend parking lot, LED sign, Breezeway, Windows, HVAC) \$800,000
- 4. Tech/Security (System-wide networked cameras, Access control entries with key card teacher badges electronic gates at TCES, Interactive Panels in classrooms) \$800,000
- 5. Pit- (Turf the field- City is partnering \$15,000 annually for 10 years). \$800,000

Total-\$5,150,000

- This would give us about \$350,000 cushion in case of overages in projects
- Also to start the new SPLOST cycle, we will have approx. \$1,000,000 of SPLOST carryover.
- In total not counting the bonds of \$5,150,000 of listed approximations of projects, we
 would maintain approx. \$1,350,000 of SPLOST surplus to continue new projects or
 continue to build on technology, safety, capital projects, school buses, infrastructure
 needs.
