ON 9/25/2019, I RESPONDED TO 887 EUGENE DEAL ROAD IN REFERENCE TO A SUSPICIOUS INCIDENT. I MET WITH THE LISTED COMPLAINANT WHO STATED THAT HER SON RECEIVED 3 PHONE CALLS FROM A RESTRICTED NUMBER EARLIER THAT EVENING. **INCIDENT NARRATIVE:**

ON 09/26/2019 AT APPROXIMATELY 1002 HOURS, I MET WITH THE COMPLAINANT JEAN RAEKE AT 13 JACKSON ROAD IN REFERENCE TO HER HUSBAND ALBERT RAEKE TAKING HER MEDICATION.

RAEKE STATED THAT ALBERT HAS BEEN GOING INTO HER ROOM AND TAKING XANAX PILLS OUT OF HER MEDICATION BOTTLE. RAEKE SAID THAT SHE IS PRESCRIBED THE MEDICATION FOR ANXIETY AND PANIC ATTACKS. RAEKE HAS AN EXTENSIVE MEDICAL HISTORY AND HAS NO WAY OF SECURING HER MEDICATIONS.

I SPOKE TO ALBERT AND HE STATED THAT SHE HAS AN EXTENSIVE MEDICAL HISTORY TO INCLUDED KNEE PAIN BACK PAIN, AND BI-POLAR DISORDER. ALBERT SAID THAT HE DID TAKE RAEKE'S XANAX FROM HER PILL BOTTLE BECAUSE IT HELPED WITH HIS BACK PAIN.

I EXPLAINED TO ALBERT THAT XANAX IS FOR ANXIETY AND IN NO WAY HAS ANY EFFECT ON HIS PAIN. ALBERT ADMITTED TO TAKING OTHER MEDICATIONS FOR HIS OWN ANXIETY AND BI-POLAR DISORDER SUCH AS SEROQUEL, WHICH IS A HEAVY SEDATIVE.

RAEKE STATED THAT SHE DID NOT WANT TO PROSECUTE ALBERT AT THIS TIME. I ADVISED ALBERT THAT TAKING ANOTHER'S MEDICATION IS A FELONY AND THAT HE COULD BE TAKEN TO JAIL FOR THIS OFFENSE. I TOLD RAEKE TO FIND A WAY TO SECURE HER MEDICATIONS AND I TOLD BOTH PARTIES THAT ALBERT HAS A PRESCRIPTION MEDICATION ADDICTION AND THAT THEY SHOULD SEEK HELP FOR HIS ADDICTION.

I PULLED A CASE NUMBER FOR SUSPICIOUS INCIDENT AND THE CASE IS CURRENTLY INACTIVE.

**INCIDENT NARRATIVE:**

ON 09/26/2019 AT APPROXIMATELY 1311 HOURS I MET WITH THE COMPLAINANT, BRENDA NEESE, AT 711 BROOKWOOD DRIVE IN REFERENCE TO SUSPICIOUS ACTIVITY.

NEESE STATED THAT AT APPROXIMATELY 1114 HOURS SHE RECEIVED A PHONE CALL FROM NUMBER 1-844-947-8747. NEESE SAID THAT SHE SPOKE TO A FEMALE THAT IDENTIFIED HERSELF AS BEING AN OFFICER WITH THE UNITED STATES SOCIAL SECURITY ADMINISTRATION. THE FEMALE SAID THAT HER NAME WAS AMY JOHNSON AND THAT HER BADGE NUMBER WAS (742609310).

JOHNSON TOLD NEESE THAT SHE HAD A WARRANT FOR ARREST BECAUSE SHE HAD PURCHASED A COROLLA AND THAT THERE WERE DRUGS FOUND IN THE CAR. JOHNSON SAID THAT NEESE HAD WARRANTS FOR DRUG TRAFFICKING AND MONEY LAUNDERING IN TEXAS. JOHNSON WENT ON TO TELL NEESE THAT SHE WOULD NEED TO GET A NEW SOCIAL SECURITY NUMBER, THAT THEY WOULD BE FREEZING HER BANK ACCOUNTS, AND SHE WOULD NOT BE RECEIVING ANY SOCIAL SECURITY BENEFITS.

JOHNSON THEN TRANSFERRED NEESE TO A MALE WHO IDENTIFIED HIMSELF AS BEING AN AGENT WITH THE SOCIAL SECURITY ADMINISTRATION AS BEING RICK JONES BADGE NUMBER (199371). JONES TOLD NEESE THAT HE WAS COMING TO ARREST HER AT HER RESIDENCE AT APPROXIMATELY 1300 HOURS UNLESS SHE WENT TO A DOLLAR GENERAL AND PUT MONEY ON AN E-CARD TO SEND TO HIM.

NEESE STATED THAT SHE TOLD JONES THAT THIS WAS A SCAM AND HUNG UP THE PHONE. NEESE SAID THAT AFTER DISCUSSING THE INCIDENT WITH A FRIEND, SHE DECIDED TO REPORT THE INCIDENT TO THE SHERIFF'S DEPARTMENT.

I RAN NEESE'S NAME IN GCIC AND SHE WAS FOUND TO HAVE NO ACTIVE WARRANTS. NEESE AND I CALLED THE SAME NUMBER THAT CALLED HER PHONE (1-844-947-8747). BOTH NEESE AND I WERE HUNG UP ON WHEN WE ATTEMPTED TO SPEAK TO THE MALE ON THE OTHER END THAT ANSWERED THE PHONE SAYING "SOCIAL SECURITY ADMINISTRATION".

I ADVISED NEESE TO CONTACT HER BANKS AND SIGN UP FOR A CREDIT MONITORING SERVICE BECAUSE HER IDENTITY COULD HAVE BEEN COMPROMISED. I PULLED A CASE NUMBER FOR A SUSPICIOUS INCIDENT AND THE CASE IS CURRENTLY INACTIVE.

AT APPROXIMATELY 1709 HOURS I RECEIVED A PHONE CALL FROM NEESE STATING SHE WAS CONTACTED AGAIN, BUT BY A DIFFERENT NUMBER. THE NUMBER USED THIS TIME WAS (1-202-918-6208). I ADVISED NEESE NOT TO ANSWER ANY FUTURE PHONE CALLS FROM NUMBERS SHE DID NOT RECOGNIZE.

**INCIDENT NARRATIVE:**

ON 09/26/2019 AT APPROXIMATELY 1715, I RESPONDED TO AAA DISCOUNT HOMES IN REFERENCE TO A DAMAGE TO PROPERTY. UPON ARRIVAL, I MADE CONTACT WITH THE COMPLAINANT, IDENTIFIED AS MRS. TOMMA JACKSON. MRS. JACKSON STATED THAT SHE WAS DRIVING SOUTH ON HIGHWAY 301 SOUTH WHEN A ROCK CAME UP FROM THE ROAD AND STRUCK HER WINDSHIELD. MRS. JACKSON STATED THAT THE ROCK FLEW OUT FROM UNDER THE TIRE OF AN 18 WHEELER TRUCK HAULING A MOBILE HOME.

I MADE CONTACT WITH THE DRIVER OF THE 18 WHEELER, IDENTIFIED AS MR. RAY LEAVENS. MR. LEAVENS STATED THAT HE DID NOT KNOW ANYTHING ABOUT THE ROCK FLYING UP. MR. LEAVENS STATED THAT MRS. JACKSON WAS IN THE LEFT HAND LANE PASSING HIM IN A GROUP OF APPROXIMATELY 4 OR 5 CARS. MR. LEAVENS STATED THAT MRS. JACKSON THEN BEGAN BLOWING HER HORN AT HIM AND TELLING HIM TO PULL OVER. MR. LEAVENS STATED THAT HE WAS DELIVERING A MOBILE HOME TO AAA DISCOUNT HOMES WHEN THIS INCIDENT OCCURRED. MRS. JACKSON CONTACTED BULLOCH COUNTY SHERIFF'S OFFICE FROM THE PARKING LOT.

BOTH PARTIES STATED THAT IT OCCURRED WHILE TRAVELING SOUTH DOWN HIGHWAY 301 SOUTH. BOTH PARTIES WERE ADVISED THAT A DAMAGE TO PROPERTY REPORT WOULD BE FILED.

**INCIDENT NARRATIVE:**

ON 9/26/2019, I RESPONDED TO 52 ROCKY RD IN REFERENCE TO A BURGLARY. UPON MY ARRIVAL, I MET WITH COMPLAINANT, JAMES TAYLOR. MR. TAYLOR ADVISED ME THAT HE ARRIVED ON THE PROPERTY AND OBSERVED THAT THE WINDOW NEAR THE MAIN DOOR WAS OPENED AS IF SOMEONE WENT INSIDE OF THE HOME. MR. TAYLOR ADVISED ME THAT NO ONE SHOULD HAVE BEEN AT THE RESIDENCE. HE STATED THE LAST TIME HE WAS AT THIS RESIDENCE WAS ABOUT 10-11 MONTHS AGO. MR. TAYLOR ADVISED THAT HE WENT INSIDE OF THE RESIDENCE AND THERE WAS NO ONE LOCATED INSIDE. HE STATED HE CLOSED THE WINDOW THAT HE SAW WAS OPENED. AS I WAS TALKING TO MR. TAYLOR, HE STATED HE HAD A TRAIL CAMERA SET UP NEAR THE DRIVE WAY AND WAS ABLE TO PROVIDE ME WITH A SIM CARD. WE WERE ABLE TO LOOK AT THE PICTURES ON THE SIM CARD AND I OBSERVED MANY VEHICLES ENTERING THE PROPERTY. MR. TAYLOR DID NOT RECOGNIZE ANY OF THE VEHICLES SHOWN IN THE PHOTOS.

MR. TAYLOR COULD NOT ADVISED ME ON ALL OF THE ITEMS THAT HE BELIEVED TO HAVE BEEN TAKEN OUT OF THE RESIDENCE. MR. TAYLOR ADVISED ME THAT HIS MOTHER WOULD KNOW MORE ABOUT THE STOLEN ITEMS BUT SHE WAS NOT PRESENT AT THE TIME THIS WAS BEING REPORTED. MR. TAYLOR WAS GIVEN AN ITEM CHECK LIST TO FILL OUT AND RETURN TO THE BULLOCH COUNTY SHERIFF'S OFFICE AS SOON AS POSSIBLE SO THE ITEMS COULD GET ENTERED.

I WENT INSIDE THE RESIDENCE AND OBSERVED. THE RESIDENCE LOOKED RANSACKED. I TOOK PICTURES OF THE INSIDE OF THE HOME AND OUTSIDE OF THE HOME. I PRIMARILY FOCUSED ON THE WINDOW THAT MR. TAYLOR ADVISED WAS OPEN UPON HIS ARRIVAL. THE WINDOW LOOKED AS IF IT HAD SPIDER WEBS ALL OVER IT. THE WINDOW DID NOT APPEAR TO BE TAMPERED WITH.

AT THIS TIME, PHOTOS HAVE BEEN UPLOADED TO THIS REPORTED AND THIS CASE WILL BE TURNED OVER TO INVESTIGATIONS FOR FURTHER ACTIONS. THE PROPERTY WILL BE ADDED IN THE REPORT WHEN THE LIST OF ITEMS IS TURNED IN.

ON THE ABOVE DATE AND TIME, I SPOKE WITH THE COMPLAINANT VIA TELEPHONE IN REFERENCE TO AN OVERDUE MOTORIST. HE EXPLAINED TO ME THAT HIS GIRLFRIEND (THE OFFENDER) HAD BEEN LIVING WITH HIM FOR TWO MONTHS AND HE RECENTLY DECIDED HE WAS GOING TO KICK HER OUT. WHEN HE LEFT HIS RESIDENCE AT APPROXIMATELY 12PM, HE TOLD HER TO HAVE ALL HER BELONGINGS PACKED WHEN HE GOT BACK FROM WORK AND HE WOULD TAKE HER SOMEWHERE ELSE. BUT WHEN HE RETURNED FROM WORK, SHE AND HIS TRUCK WERE GONE. HE STATED HE ATTEMPTED TO CALL HER AND TEXT HER TO BRING IT BACK MULTIPLE TIMES AND SHE REPLIED SHE WAS GOING TO DO SO.

I WAS ABLE TO SPEAK WITH THE OFFENDER VIA TELEPHONE AS WELL. SHE INFORMED ME OF THE SITUATION AND STATED SHE TOLD HIM SHE WAS GOING TO BE BRINGING THE TRUCK BACK SOON. SHE STATED SHE HAS USED THE TRUCK NUMEROUS TIMES IN THE PAST AS WELL. I ADVISED HER IT WOULD BE BEST TO RETURN THE TRUCK TO HIM AS SOON AS POSSIBLE. THE COMPLAINANT WAS ADVISED TO CALL THE SHERIFF'S OFFICE ONCE SHE RETURNED THE VEHICLE.
