RE: Open Records Complaint from Jessica Szilagyi regarding the City of Guyton

Dear Judge Smith:

I am writing regarding a complaint our office received from Ms. Jessica Szilagyi about an Open Records request she submitted to the City of Guyton. On October 28, 2019, Ms. Szilagyi requested the personnel file of Interim Police Chief Joseph Coppola, including complaints filed against him, as well as other records. A scanned copy of his personnel file was provided to her on October 22, 2019. Ms. Szilagyi noted that the personnel file did not contain any training records after 2017 and asked for those records to be made available if they existed. She followed up with the city several times but still has not received the records or a timeline for when they will be available.

Under Georgia law the Attorney General, as an independent constitutional officer, has the discretionary authority to enforce the Open Records Act and the Open Meetings Act. O.C.G.A. §§ 50-18-73(a), 50-14-5(a). The Attorney General has chosen to exercise that discretion by establishing a mediation program where citizens may raise issues and concerns with us regarding the Acts, and we will attempt to resolve disputes between citizens and local government.

I am not aware of all the circumstances surrounding Ms. Szilagyi's request, and I am not assuming the city violated the law. I have enclosed a copy of Ms. Szilagyi's correspondence
