INCIDENT NARRATIVE:

ON 03/20/2020 I SPOKE WITH MR. MICAH JETT VIA TELEPHONE IN REFERENCE TO A THEFT.

MR. JETT STATED THAT HE AND MR. RICKY SMILEY AGREED THAT MR. JETT WOULD PERFORM MECHANICAL WORK ON MR. SMILEYS VEHICLE (2005 CHEVROLET SILVERADO) AT THE INCIDENT LOCATION ON THIS REPORT. MR. JETT STATED THAT AFTER THE WORK WAS PERFORMED AND COMPLETED, MR. SMILEY INSPECTED THE VEHICLE AND SEEMED PLEASED WITH THE OUTCOME. MR. JETT CONTINUED TO STATE THAT HE EXPLAINED TO MR. SMILEY THAT HE GUARANTEES ALL OF HIS WORK AND IF THERE ARE ANY ISSUES TO CONTACT HIM AND THEY WILL BE ADDRESSED. MR. SMILEY THEN WROTE MR. JETT A CHECK FROM HIS BUSINESS ACCOUNT IN THE AMOUNT OF \$2802.21 FOR THE REPAIRS AND LEFT WITH THE VEHICLE IN GOOD WORKING ORDER. MR. JETT STATED THAT THE FOLLOWING DAY (AFTER THE VEHICLE WAS PICKED UP) MR. SMILEY CALLED MR. JETT TO COMMEND HIM ON THE OUTSTANDING WORK HE HAD DONE ON THE VEHICLE.

MR. JETT TOOK THE CHECK TO HIS BANKING INSTITUTION AND CASHED IT ON 3/14/2020 WITH NOT ISSUES. HE WAS THEN CONTACTED BY HIS BANKING INSTITUTION AND ADVISED THAT MR. SMILEY HAD STOPPED PAYMENT ON THE CHECK, FORCING MR. JETT TO PAY THE AMOUNT OUT OF HIS POCKET BACK TO THE BANK.

MR. JETT STATED THAT HE HAS ATTEMPTED TO CONTACT MR. JETT MULTIPLE TIMES VIA TELEPHONE BUT HIS ATTEMPTS WERE UNSUCCESSFUL. HE ALSO STATED THAT MR. SMILEY HAS NOT ATTEMPTED TO CONTACT HIM OR HIS BUSINESS.

I MADE CONTACT WITH MR. SMILEY VIA TELEPHONE. MR. SMILEY EXPLAINED THAT HE DID IN FACT ALLOW MR. JETT TO WORK ON HIS VEHICLE AT THE INCIDENT LOCATION. MR. SMILEY STATED THAT HE WAS NOT CONTENT WITH THE REPAIRS HOWEVER, AGREED TO PAY MR. JETT THE \$2802.21 VI CHECK AND TOOK THE VEHICLE.

MR. SMILEY STATED THAT HE THEN TOOK THE VEHICLE TO ANOTHER MECHANIC SHOP AND WAS ADVISED THAT THERE WERE MANY MALFUNCTIONS THAT WERE NOT CORRECTED BY MR. JETT AND THAT HE WAS GOING TO HAVE TO SPEND A SIGNIFICANT AMOUNT OF MONEY TO REPAIR THE VEHICLE. MR. SMILEY STATED THAT HE THEN STOPPED PAYMENT ON THE CHECK BECAUSE HE DID NOT BELIEVE IT WAS FAIR. I EXPLAINED TO MR. SMILEY THAT ONCE HE ENTERED INTO AGREEMENT TO PAY MR. JETT HE IS OBLIGATED FOR THAT AMOUNT.

MR. SMILEY STATED THAT HE IS GOING TO CONTACT MR. JETT AND SPEAK WITH HIM ABOUT RESOLVING THIS MATTER. BOTH PARTIES WERE ADVISED THAT I WOULD FOLLOW UP THEM ON 03/23/2020. UNTIL THAT TIME THIS CASE WILL REMAIN ACTIVE.

INCIDENT NARRATIVE:

ON 3/21/2020 I MADE CONTACT WITH MRS. LISA THORNTON IN REFERENCE TO A MISSING FIREARM AT HER RESIDENCE. MRS. THORNTON ADVISED ME THAT SHE WAS LAST AT HER RESIDENCE AND SHE ARRIVED BACK HOME THIS DATE AND NOTICED THAT HER BACK DOOR WAS UNLOCKED. MRS. THORNTON ADVISED THAT SHE WAS UNSURE IF SHE LEFT THE BACK DOOR UNLOCKED THE LAST TIME SHE WAS AT HER RESIDENCE. SHE DID NOT OBSERVE ANY SIGNS OF FORCED ENTRY AT THE RESIDENCE. MRS. THORNTON ADVISED THAT HER 9MM TAURUS WAS IN HER BACK BEDROOM DRAWER. SHE ADVISED THAT THE ONLY THING THAT APPEARED MISSING FROM THE RESIDENCE WAS THE FIREARM. MRS. THORNTON COULD NOT PROVIDE ME WITH A SERIAL NUMBER AT THIS TIME. SHE ADVISED SHE WENT TO BACKYARD ARMORY IN BROOKLET WHERE SHE PURCHASED THE FIREARM BUT THEY COULD NOT ASSIST HER WITH GIVING HER THE SERIAL NUMBER TODAY. SHE ADVISED ME SHE WOULD FOLLOW UP WITH ME ON MONDAY. FURTHERMORE, THERE ARE NO SUSPECTS AT THIS TIME, AND THE CASE WAS TURNED OVER TO THE CRIMINAL INVESTIGATIONS DIVISION.

INCIDENT NARRATIVE:

ON 03/22/2020, I, DEPUTY R. SHAFER WAS DISPATCHED TO 227 LEE AVENUE, IN REFERENCE TO A PHYSICAL DOMESTIC. WHEN I ARRIVED I SPOKE TO THE VICTIM. THE VICTIM ADVISED THE OFFENDER GOT UPSET ABOUT THE OFFENDER'S GIRLFRIEND DRINKING WHILE BREAST FEEDING. THE VICTIM ADVISED THAT THE OFFENDER STARTED YELLING, AND THAT THE VICTIM TRIED TO CALM THE OFFENDER DOWN AND THEN THEY FOUGHT.

AFTER BOTH SUBJECTS FOUGHT, THE OFFENDER LEFT THE SCENE AND CALLED IN THE PHYSICAL DOMESTIC.

THE VICTIM ADVISED HE DID NOT WANT TO PRESS CHARGES, AND SIGNED A WAIVER OF PROSECUTION.

INCIDENT NARRATIVE:

ON THE ABOVE DATE AND TIME, WE RESPONDED TO A CALL IN REFERENCE TO A DOMESTIC DISPUTE. THE CALLER STATED THAT HER DAD WHO DOES NOT LIVE THERE SHOWED UP TO THE RESIDENCE OF HER AND HER MOTHER AND BEGAN TO MAKE THREATS TO THEM. SHE STATED THAT HE WANTED TO TALK AND WAS KNOCKING ON THE DOOR BUT THEY DID NOT LET HIM IN. THE COMPLAINANT STATED THAT SHE FEARED HE WOULD TRY TO DO SOMETHING TO THEM SO SHE GRABBED HER FIREARM IN PREPARATION.

WHILE ON SCENE, THE COMPLAINANT STATED THAT SHE BELIEVED THE OFFENDER WAS WALKING ON THE DIRT ROAD BEHIND THEIR HOUSE. WE WERE ABLE TO LOCATE HIM AND ATTEMPTED TO CALL HIM OVER BUT HE APPEARED TO IGNORE US. WHILE DOING SO, THE COMPLAINANT WAS ACTING VERY FRANTIC AND STATED THAT HE HAD A GUN MULTIPLE TIMES. NOT KNOWING WHAT HIS INTENTIONS WERE WE DECIDED NOT TO FURTHER ATTEMPT TO APPROACH HIM. AT THIS TIME, THE OFFENDER LEFT THE SCENE IN HIS VEHICLE.

THE OFFENDER THEN CALLED THE COMPLAINANT ON THE PHONE. WE WERE ABLE TO SPEAK WITH HIM OVER THE PHONE SO THAT WE COULD MEET WITH HIM AND TALK TO HIM. HE AGREED TO MEET US AT THE GAS STATION AT 301 SOUTH AND THE BYPASS (CIRCLE K). BEFORE I LEFT I BEGAN TO SPEAK WITH THE COMPLAINANT ONCE MORE NOW THAT SHE HAD CALMED DOWN. I ASKED IF THE OFFENDER HAD ANY BUSINESS BEING AT HER RESIDENCE AND SHE STATED THAT HE DID NOT. I THEN ASKED IF SHE WOULD LIKE HIM SERVED WITH CRIMINAL TRESPASS AND SHE STATED SHE DID.

WE WERE THEN ABLE TO MAKE CONTACT WITH THE OFFENDER AT CIRCLE K. THE OFFENDER STATED HE WENT OVER TO HIS DAUGHTER AND EX WIFE'S RESIDENCE TO TALK ABOUT SOME THINGS THAT HAPPENED WHILE HE WAS IN PRISON. HE STATED THAT THE COMPLAINANT NO LONGER WANTED TO TALK AND TOLD HIM TO COME BACK TOMORROW MORNING. I THEN ADVISED THE OFFENDER OF THE CRIMINAL TRESPASS WARNING PROCESS AND SERVED HIM ON SCENE. HE STATED HE UNDERSTOOD. REPORT FOR DOCUMENTATION.
