ON 04/22/2020, I, DEPUTY R. SHAFER WAS DISPATCHED TO A CALL VIA PHONE IN REFERENCE TO HARASSING COMMUNICATIONS. I SPOKE WITH MS. NATALIE SANDS. MS. SANDS ADVISED ME THAT MR. SCOTTIE DURRENCE HAS BEEN CALLING HER PHONE THROUGH VARIOUS NUMBERS AS WELL AS HER FAMILY TRYING TO GET IN CONTACT WITH HER, AS WELL AS USING PEOPLES FACEBOOK TO CONTACT HER. I ADVISED MS. SANDS I WOULD MAKE A REPORT FOR DOCUMENTATION AS WELL AS CONTACTING MR. DURRENCE AND ADVISED HIM THAT SHE WANTS NO CONTACT.

I SPOKE TO MR. DURRENCE VIA PHONE AND ADVISED HIM OF THE SITUATION. MR. DURRENCE ADVISED THAT HE IS CONCERNED ABOUT MS. SANDS AND THEIR DAUGHTER. I ADVISED MR. DURRENCE TO SPEAK TO A LAWYER IN REFERENCE TO TALKING TO HIS DAUGHTER SINCE MS. SANDS HAS CUSTODY OF THEIR DAUGHTER. MR. DURRENCE ADVISED HE UNDERSTOOD.

SHE STATED THAT THEY RECENTLY HAD NEW ARRANGEMENTS FOR HIM VISITING THEIR CHILD WHERE IT HAD BEEN GOING WELL. SHE THEN STATED HE BECAME UPSET ABOUT SOMETHING AND THAT'S WHEN HE STARTED ALL THIS.

THE COMPLAINANT ADVISED SHE WANTED TO HAVE THIS INCIDENT DOCUMENTED DUE TO HER NOT FEELING SAFE WITH THE OFFENDER AND ALSO HIM CONTACTING HER. THE COMPLAINANT ADVISED THAT SHE RECENTLY HAS FILED TWO OTHER REPORTS AGAINST THE OFFENDER FOR OTHER VIOLENT INCIDENTS. I ADVISED THE COMPLAINANT OF THE PROCESS TO OBTAIN A TEMPORARY PROTECTION ORDER. ALSO NO CONTACT WITH THE OFFENDER WAS MADE.
