INCIDENT NARRATIVE:

ON 04/28/2020 AT APPROXIMATELY 1934 I MET WITH THE COMPLAINANT, CHAINEY GARRIS, AT 23 BROOMSTRAW TRACE ROAD IN REFERENCE TO HARASSING COMMUNICATIONS. CHAINEY EXPLAINED THAT SHE HAS ADOPTED HER HUSBAND'S CHILD, TOMMY GARRIS, AND THAT HER HUSBAND'S EX-WIFE'S FAMILY MEMBERS HAVE BEEN SENDING HER HARASSING MESSAGES THROUGH FACEBOOK AND HAVE BEEN DRIVING BY THE RESIDENCE.

CHAINEY SAID THAT HER HUSBAND, JIMMY GARRIS, RECEIVED FULL CUSTODY OF TOMMY THROUGH THE EFFINGHAM COUNTY COURT WHEN HE WAS ABANDONED BY HIS MOTHER. CHAINEY STATED THAT SHE THEN ADOPTED TOMMY THROUGH THE BULLOCH COUNTY COURTS AND THAT SHE AND JIMMY HAVE SOLE CUSTODY OF TOMMY.

CHAINEY SAID THAT SHE HAS SEEN TOMMY'S GREAT GRANDMOTHER, RUTH LEWIS, DRIVING BY THE RESIDENCE SLOWLY OBSERVING THE HOUSE IN A SILVER 4 DOOR SUV. CHAINEY STATED THAT SHE HAS ALSO SEEN TOMMY'S AUNT, AMANDA MOONE, PARKED AT THE STOP SIGN NEXT TO THE RESIDENCE WATCHING THE HOUSE. CHAINEY ALSO SAID THAT ONE INSTANCE, LEWIS AND MOONE SLOWLY DROVE BY THE RESIDENCE AND YELLED TO TOMMY THAT THEY WOULDN'T LET CHAINEY AND JIMMY KEEP HIM FROM THEM, AND SPED AWAY AS THEY SAW CHAINEY SITTING ON THE FRONT PORCH.

CHAINEY STATED THAT BOTH LEWIS AND MOONE HAVE BEEN HARASSING HER ON FACEBOOK AND WHEN SHE BLOCKS THEIR ACCOUNTS THEY CREATE NEW ONES AND CONTINUE TO HARASS HER. CHAINEY ALSO SAID THAT BOTH LEWIS AND MOONE CALL FROM DIFFERENT PHONE NUMBERS AND TEXT HER FROM THE NUMBERS HARASSING HER. CHAINEY STATED THAT SHE IS TIRED OF THE HARASSMENT AND WANTS IT TO STOP.

CHAINEY WAS UNABLE TO GIVE BIRTHDATES OF LEWIS AND MOONE, SO I SPOKE TO JIMMY. JIMMY WAS UNABLE TO GIVE AN EXACT ADDRESS BUT SAID THAT LEWIS LIVES ON EXLEY ROAD IN EFFINGHAM COUNTY OFF OF HIGH BLUFF ROAD. JIMMY DID NOT KNOW LEWIS OR MOONE'S BOTH DATES OR PHONE NUMBERS EITHER.

I ADVISED BOTH CHAINEY AND JIMMY OF REMEDIES AND PULLED A CASE NUMBER FOR HARASSING COMMUNICATIONS. THE COMPLAINANT WAS ALSO ADVISED TO CALL AGAIN IF THE HARASSMENT CONTINUED.

INCIDENT NARRATIVE:

ON 04/28/2020 AT APPROXIMATELY 2331 WHILE ON THE SCENE AT DRY BRANCH VILLAGE INVESTIGATING ANOTHER CALL FOR SERVICE, I COULD HEAR THE OFFENDER, LATER IDENTIFIED AS BEING MARQUIS DEANDRE MIKELL AT CYPRESS LAKE MHP LOT 14 ACROSS THE FENCE PLAYING HIS RADIO IN THE FRONT YARD OF HIS RESIDENCE, WHICH COULD BE HEARD FROM A DISTANCE OF APPROXIMATELY 100 FEET AND SINGING. MIKELL BEGAN YELLING ACROSS THE FENCE AT MYSELF AND OTHER DEPUTIES ABOUT US SHINING OUR FLASH LIGHTS AS WE INVESTIGATED THE OTHER CALL FOR SERVICE. I IDENTIFIED MY SELF AS THE BULLOCH COUNTY SHERIFF'S OFFICE AND GAVE MIKELL THE LAWFUL COMMAND TO TURN OFF THE RADIO. MIKELL REFUSED AND ARGUED YELLING AT ME FROM ACROSS A FENCE THAT HE DIDN'T HAVE TO TURN OFF THE RADIO, THAT HE WAS IN HIS YARD, AND I WAS NOT HIS LANDLORD.

MIKELL THEN BEGAN PLAYING A SONG LOUDLY AND YELLING AT THE TOP OF HIS VOICE ALONG WITH THE SONG THE WORDS "FUCK THE POPO". AFTER I HAD COMPLETED MY DUTIES AT THE OTHER CALL FOR SERVICE, I WENT TO MIKELL'S RESIDENCE AT CYPRESS LAKE MHP LOT 14. AS I PULLED INTO MIKELL'S DRIVEWAY, MIKELL WHO WAS HOLDING A BEER BOTTLE AND ANOTHER MALE WERE SITTING IN THE FRONT YARD AND TURNED OFF THE RADIO. MIKELL ARGUED THAT I COULD NOT BE IN HIS YARD, AND WHEN I TOLD HIM TO COME TO ME, HE AND THE OTHER MALE IMMEDIATELY RAN INSIDE OF THE RESIDENCE, AND LOCKED THE DOOR.

AS I APPROACHED THE FRONT DOOR, I FOUND IT TO HAVE A LARGE GLASS WINDOW PANE FROM TOP TO BOTTOM, AND MIKELL WAS STANDING ON THE OTHER SIDE FROM INSIDE OF THE RESIDENCE STILL HOLDING A BEER BOTTLE. I TOLD MIKELL TO COME OUTSIDE OF THE RESIDENCE AND HE REFUSED. MIKELL SAID THAT I HAD TO HAVE A WARRANT TO BE ON HIS PROPERTY AND REFUSED TO OPEN THE DOOR OR COME OUTSIDE OF THE RESIDENCE. MIKELL SAID HE WAS GOING TO CALL THE SHERIFF AND DISAPPEARED INTO THE RESIDENCE. A FEMALE INSIDE OF THE RESIDENCE CAME TO THE DOOR AND MIKELL RETURNED AND TOLD HER NOT TO OPEN THE DOOR. MIKELL WAS REPEATEDLY TOLD TO OPEN THE DOOR AND HE REFUSED. MIKELL THEN SAID HE WAS ON THE PHONE WITH HIS LAWYER, AND HIS LAWYER TOLD HIM HE DID NOT HAVE TO OPEN THE DOOR. I ASKED MIKELL TO IDENTIFY HIMSELF AND HE SAID HIS NAME WAS TREY, BUT WAS DIFFICULT TO HEAR WITH SLURRED SPEECH AND FROM YELLING THROUGH THE GLASS.

A GREY 2008 CHEVROLET MALIBU WITH TAG# P0902567 WAS PARKED OUTSIDE OF THE RESIDENCE. THE TAG NUMBER WAS RAN IN GCIC AND FOUND TO BE REGISTERED TO MIKELL. I WAS ABLE TO POSITIVELY IDENTIFY MIKELL WITH THE PICTURE PROVIDED BY GCIC. IT WAS CONFIRMED THAT MIKELL HAD GIVEN ME A FALSE NAME. MIKELL STILL REFUSED TO EXIT THE RESIDENCE AND I PULLED A CASE NUMBER FOR OBSTRUCTION.

OTHER DEPUTIES AND MYSELF THEN LEFT THE RESIDENCE AND I WILL OBTAIN ARREST WARRANTS ON 04/29/2020 FOR THE ARREST OF MIKELL WITH CHARGES OF PUBLIC DRUNKENNESS, DISORDERLY CONDUCT, GIVING A FALSE NAME, MAINTAINING A DISORDERLY HOUSE, AND OBSTRUCTION. THIS CASE IS CURRENTLY INACTIVE.
