INCIDENT NARRATIVE:

ON 05/20/2020 I SPOKE WITH MR. BLAKE PROTZMAN VIA TELEPHONE IN REFERENCE TO A SUSPICIOUS INCIDENT.

MR. PROTZMAN STATED THAT HE RENTS THE PROPERTY AT THE INCIDENT LOCATION ON THIS REPORT THROUGH PMG PROPERTIES. HE CONTINUED TO STATE THAT HIS LEASE ENDS ON 05/30/2020. AS AGREED IN THE CONTRACT, THE PROPERTY CAN BE SHOWN TO POTENTIAL FUTURE TENANTS WITH A 24 HOUR NOTICE TO MR. PROTZMAN.

MR. PROTZMAN STATED THAT DURING THE INCIDENT TIMES ON THIS REPORT, HE BELIEVED SOMEONE FROM PMG RENTALS SHOWED THE HOME TO A POTENTIAL TENANT AND THAT HE WAS NOT NOTIFIED. MR. PROTZMAN STATED THAT HE HAS KNOWLEDGE OF THIS DUE TO THE DOOR LEADING INTO THE HOME FROM INSIDE THE GARAGE WAS DEAD BOLTED FROM THE INSIDE AND WHEN HE LEFT THE LOCATION PRIOR, THE DOOR WAS UNLOCKED.

THAT NUMBER WAS PROVIDED ALONG WITH THE PHONE NUMBER THAT HE PROVIDED TO ME TODAY. MR. WINDHAM DID STATE THAT THEY HAVE CONTACTED MR. PROTZMAN AT THIS NUMBER IN THE PAST BUT MORE RECENTLY HE HAS BEEN CONTACTED AT THE NUMBER THAT WAS PROVIDED TO ME THIS DATE. MR. WINDHAM STATED THAT HE IS UNAWARE IF MR. PROTZMAN REQUESTED THE "OLD" PHONE NUMBER TO BE REMOVED FROM HIS FILE HOWEVER, HE DID NOT SEE A RECORD OF THE CHANGE.

MR. WINDHAM STATED THAT HE WOULD REACH OUT TO MR. PROTZMAN AND APOLOGIZE FOR THE MISUNDERSTANDING. MR. PROTZMAN WANTED THIS INCIDENT CONDUCTED FOR DOCUMENTATION PURPOSES ONLY. NO DAMAGE WAS FOUND IN OR AROUND THE INCIDENT LOCATION AND NO ITEMS WERE MISSING.

MS. WELLS STATED THAT SHE AND MR. TAB WELLS HAVE A JUVENILE CHILD (11 YEARS OLD) TOGETHER FROM A PREVIOUS ROMANTIC RELATIONSHIP. MS. WELLS STATED THAT A CUSTODY AGREEMENT WAS PREVIOUSLY SIGNED THROUGH SUPERIOR COURT IN BULLOCH COUNTY FOR JOINT CUSTODY/VISITATION OF THE CHILD.

ON OR ABOUT 04/03/2020 MR. WELLS TOOK THE CHILD INTO HIS CARE WITH THE AGREEMENT THAT HE WOULD RETURN THE CHILD A FEW DAYS LATER (PER COURT PAPERWORK). SOON AFTER, MR. WELLS ADVISED MS. WELLS THAT DUE TO COVID-19 HE WAS NOT GOING TO RETURN THE CHILD TO HER UNTIL HE FELT IT WAS A SAFE ENVIRONMENT TO DO SO. MS. WELLS STATED THAT SHE HAS CONTINUOUSLY ASKED FOR MR. WELLS TO RETURN THE CHILD TO HER BUT HE REFUSES.

MS. WELLS WAS ADVISED THAT A REPORT WOULD BE DOCUMENTED FOR CUSTODY INTERFERENCE AND ADVISED ON MAGISTRATE COURT PROCEDURES. NOTHING FURTHER AT THIS TIME.

WELLS STATED THAT SHE PLANS ON FILING FOR A DIVORCE SOON AND HAVING A CUSTODY AGREEMENT OUTLINED IN THE DIVORCE DECREE. MS. WELLS WAS ADVISED OF REMEDIES AND PROCEDURES TO INCLUDE MAGISTRATE COURT AND SUPERIOR COURT PROCEEDINGS. NOTHING FURTHER AT THIS TIME. (WITNESS STATEMENT ATTACHED)
