MS. SULLIVAN STATED THAT SHE RECENTLY RECEIVED A MASTERCARD DEBIT CARD FOR UNEMPLOYMENT BENEFITS IN HER MAILBOX WITH HER NAME, ADDRESS, PERSONAL INFORMATION, ETC.

MS. SULLIVAN ATTEMPTED TO CONTACT THE DEPARTMENT OF LABOR TO REPORT THAT SHE WAS WORKING FULL TIME AND DID NOT FILE FOR UNEMPLOYMENT HOWEVER, SHE WAS UNABLE TO CONTACT ANYONE AT THE DEPARTMENT OF LABOR. MS. SULLIVAN THEN CONTACTED MASTERCARD AND WAS ADVISED THAT THEY COULD NOT PLACE A LOCK OR CANCEL THE CARD AND REFERRED HER BACK TO THE DEPARTMENT OF LABOR.

SINCE 05/01/2020 A TOTAL AMOUNT OF \$4376.00 HAS BEEN DEPOSITED ONTO THE CARD ACCOUNT. MS. SULLIVAN HAS NOT USED THE CARD AND BELIEVES SOMEONE MAY HAVE STOLEN HER IDENTITY TO APPLY FOR THE UNEMPLOYMENT. NONE OF THE FUNDS HAVE BEEN REMOVED FROM THE CARD.

I ATTEMPTED TO CONTACT THE DEPARTMENT OF LABOR AT 5 DIFFERENT PHONE NUMBERS. ALL OF MY ATTEMPTS WERE UNSUCCESSFUL IN REACHING AN EMPLOYEE IN THE FRAUD DEPARTMENT. SEVERAL RECORDINGS ADVISED THAT OFFICES WERE CLOSED DUE TO THE COVID-19 PANDEMIC.

I ADVISED MS. SULLIVAN TO CONTINUE TO TRY AND MAKE CONTACT WITH THE DEPARTMENT OF LABOR. I ALSO ADVISED HER TO KEEP THE ACCOUNT CHECKED TO ENSURE THAT NO MONIES ARE USED OFF OF THE CARD UNTIL SHE IS ABLE TO HAVE IT CANCELED. SHE WAS ADVISED THAT THIS REPORT WOULD BE ON FILE FOR DOCUMENTATION PURPOSES. SHE PROVIDED A SCREEN SHOT OF THE ACCOUNT AND A PHOTO OF THE LETTER SHE RECEIVED FROM THE DEPARTMENT OF LABOR (ATTACHED TO LINKED FILES) NOTHING FURTHER AT THIS TIME.
