INCIDENT NARRATIVE:

DEPUTIES AND EMERGENCY MEDICAL PERSONNEL RESPONDED TO TAMI AND SHERRI LANE FOR THE REPORT OF A WHITE FEMALE THAT HAD WALKED OUT OF THE WOODS, COMPLAINANT STATED THAT SHE SEEMED DISTRESSED AND HAD A ALTERED MENTAL STATUS.

ARRIVING, CONTACT WAS MADE WITH A WHITE FEMALE THAT WAS WEARING SHORTS, A T-SHIRT, BLACK SOCKS WITH NO SHOES. SHE WAS SCRATCHED ON HER BARE ARMS AND BARE LEGS FROM BRIARS AND LIMBS FROM WALKING THROUGH THE WOODS. AN ATTEMPT WAS MADE TO GAIN INFORMATION FROM HER, SHE STATED HER NAME WAS JESSICA, THEN BECAME UNCOOPERATIVE AND WOULD NOT GIVE A LAST NAME. SEVERAL ATTEMPTS WERE MADE TO GET INFORMATION FROM HER, DEPUTIES EXPLAINING THAT SHE WAS NOT IN TROUBLE, AND WE WOULD ASSIST HER IN ANY WAY POSSIBLE, BUT HER PERSONNEL INFORMATION WAS REQUIRED. EVERY ATTEMPT WAS MET WITH HOSTILITY AND OPPOSITION. SHE WAS ARRESTED, HANDCUFFED AND SECURED IN MY PATROL UNIT.

SHE WAS TRANSPORTED TO THE BULLOCH COUNTY OFFICE OF THE SHERIFF, WHERE SHE CONTINUED TO BE UNCOOPERATIVE. WHILE AT THE JAIL, IT WAS DISCOVERED THAT THE FEMALE'S NAME IS CHRISTINA CAIRNEY. A PHOTO IDENTIFICATION CONFIRMED HER ACTUAL NAME. CHRISTINA CAIRNEY WAS CHARGED WITH GIVING FALSE NAME, GEORGIA CODE SECTION 16-10-25, CITATION NUMBER 230000484, AND OBSTRUCTION OF LAW ENFORCEMENT, GEORGIA CODE, 16-10-24, CITATION NUMBER 230000485.
