ON 05/14/2020 I SPOKE WITH MS. KENDRA MONROE VIA TELEPHONE IN REFERENCE TO TERRORISTIC THREATS.

MS. MONROE STATED THAT DAYSHA WEST CALLED HER PHONE ON TWO SEPARATE OCCASIONS ON 05/13/2020 AND BEGAN TO YELL AND CURSE AT HER SAYING THINGS LIKE "YOU'LL BE ON A T-SHIRT BEFORE THIS IS OVER" AND "COME TO MY HOUSE I WANNA FIGHT YOU".

MS. MONROE STATED THAT SHE DID CALL MS. WEST BACK TO ASK HER HOW SHE GOT HER PHONE NUMBER AND TO TELL HER NOT TO CALL HER ANYMORE. MS. MONROE STATED THAT SHE AND MS. MONROE KNOW EACH OTHER DUE TO THE FACT THAT THEY WERE BOTH PREVIOUSLY IN A RELATIONSHIP WITH THE SAME MAN.

I MADE CONTACT WITH MS. WEST VIA TELEPHONE. MS. WEST STATED THAT MS. MONROE HAS BEEN HARASSING HER SINCE OCTOBER OF 2019 WHEN HER BOYFRIEND BEGAN SEEING MS. MONROE WHILE ALSO IN A RELATIONSHIP WITH HER. MS. WEST STATED THAT MS. MONROE HAS THREATENED HER LIFE ON MULTIPLE OCCASIONS AND THAT SHE EVEN CALLED HER JUST PRIOR TO CALLING THE SHERIFF'S OFFICE TO MAKE THIS REPORT.

ALL PARTIES WERE ADVISED TO CEASE CONTACT WITH EACH OTHER. ALL PARTIES AGREED THAT NO FURTHER CONTACT WOULD BE MADE. AVAILABLE SERVICES AND REMEDIES WERE PROVIDED. REPORT FOR DOCUMENTATION.
