PARKER HANDED OVER THE TITLE TO THE MODULAR HOME TO MR. LEE AT THAT TIME WITH THE VERBAL AGREEMENT THAT MR. LEE WOULD PAY MR. PARKER AN ADDITIONAL \$5000.00 (APPROXIMATE ESTIMATE) AT A LATER DATE.

MR. PARKER STATED THAT SINCE THAT TIME HE HAS CONTACTED MR. LEE ABOUT PAYING HIM THE MONEY (THERE WAS NOT SET DATE TO HAVE IT PAID BY) AND THAT MR. LEE HAS BEEN VERY RUDE AND CUSSSED AT MR. PARKER.

MR. PARKER WAS ADVISED ON REMEDIES AND PROCEDURES. NO PAPERWORK OR EXACT DATES COULD BE PROVIDED. ONLY A NAME AND PHONE NUMBER WERE PROVIDED FOR MR. LEE.

I ATTEMPTED TO MAKE CONTACT WITH MR. LEE VIA THE TELEPHONE NUMBER PROVIDED WITH NO SUCCESS. NOTHING FURTHER AT THIS TIME.
