ON FRIDAY, MAY 8TH, 2020 OFFICER SKIPPER WAS ON DUTY WITH THE CLAXTON POLICE DEPARTMENT, IN EVANS COUNTY, GEORGIA. OFFICER SKIPPER WAS DISPATCHED TO THE AREA OF EAST LONG STREET IN REFERENCE TO A MALE SUBJECT WALKING DOWN THE ROADWAY. DISPATCH ADVISED THAT THE SUBJECT WAS BEING FOLLOWED BY AN EMS UNIT AND THAT THE MALE SUBJECT HAD ACTUALLY HIT THE EMS UNIT AT SOME POINT. AS OFFICER SKIPPER WAS RESPONDING, DISPATCH GAVE AN UPDATE THAT THE MALE SUBJECT HAD WALKED INTO SOMEONE'S YARD AND GRABBED A LARGE PIPE AND WAS NOW WALKING DOWN THE ROADWAY WITH IT. OFFICER SKIPPER ARRIVED IN THE AREA WHERE HE OBSERVED AN EVANS COUNTY EMS UNIT WITH ITS EMERGENCY LIGHTS FLASHING, FOLLOWING BEHIND A MALE SUBJECT. THE MALE SUBJECT WAS WALKING DOWN THE ROADWAY, HOLDING A LARGE PIPE IN HIS HAND.

AS OFFICER SKIPPER ARRIVED, HE ACTIVATED HIS MARKED PATROL UNIT EMERGENCY LIGHTS AND STOPPED IN THE ROADWAY. THE MALE SUBJECT CONTINUED TO WALK TOWARDS OFFICER SKIPPERS PATROL UNIT, IN WHAT APPEARED TO BE A BLANK STARE MINDSET. OFFICER SKIPPER WAS ATTEMPTING TO UPDATE DISPATCH OF HIS EXACT LOCATION WHEN HE NOTICED THE MALE SUBJECT STILL ADVANCING TOWARDS HIS PATROL UNIT. OFFICER SKIPPER NOTICED THE MALE GRABBED THE PIPE WITH BOTH HANDS AND DREW BACK AS IF HE WAS GOING TO STRIKE OFFICER SKIPPER PATROL UNIT. OFFICER SKIPPER THEN OPENED HIS DRIVERS DOOR AND HOLLERED "HEY DON'T YOU HIT MY DAMN CAR". AS OFFICER SKIPPER DONE THIS THE MALE SUBJECT STRUCK THE PATROL UNIT ON THE DRIVERS FRONT FENDER. THE MALE SUBJECT THEN CONTINUED TO STRIKE THE DRIVERS SIDE OF THE CAR AS HE WAS WALKING TOWARDS THE OPENING OF THE DOORWAY. OFFICER SKIPPER THEN DREW HIS SERVICE WEAPON AND ORDERED THE SUBJECT TO GET BACK.

THE SUBJECT CONTINUED TO ADVANCE TOWARDS OFFICER SKIPPER AND WAS NOT COMPLYING WITH COMMANDS GIVEN TO HIM. OFFICER SKIPPER QUICKLY ATTEMPTED TO PUT HIS SERVICE WEAPON IN ITS HOLSTER AND EXIT THE VEHICLE SO HE WAS NOT CONFINED TO THE SMALL AREA. OFFICER SKIPPER ORDERED THE SUBJECT BACK AGAIN IN WHICH HE IGNORED. OFFICER SKIPPER THEN EXITED THE PATROL UNIT WHERE HE TACKLED THE SUBJECT FACE TO FACE TO THE GROUND. AS HE DONE THIS, OFFICER SKIPPERS SERVICE WEAPON FELL FROM HIS HOLSTER DUE TO NOT BEING COMPLETELY SECURED. OFFICER SKIPPER ORDERED POLICE OFFICER WESLEY KENNEDY WHOM WAS RIDING ALONG WITH OFFICER SKIPPER, TO GRAB THE GUN. OFFICER SKIPPER THEN ATTEMPTED TO PLACE THE MALE SUBJECT INTO CUSTODY, BUT HAD TO BE ASSISTED BY EMS PERSONNEL. THE MALE SUBJECT WAS HANDCUFFED BEHIND HIS BACK AND OFFICER SKIPPER GAVE DISPATCH AN UPDATE. AT THAT TIME OFFICER SKIPPER NOTICED THAT THE MALE SUBJECT HAD URINATED ON HIMSELF.

OFFICER SKIPPER AND OFFICER KENNEDY PLACED THE SUBJECT UNIT THE REAR OF UNIT 406 AWAITING EVANS COUNTY DEPUTIES TO ARRIVE. DEPUTY STEWART AND DEPUTY BREWTON ARRIVED ON SCENE WHERE THE MALE SUBJECT WAS RELEASED TO THEIR CUSTODY. OFFICER SKIPPER TOOK PHOTOGRAPHS OF HIS PATROL UNIT AND THE PIPE AND CLEARED THE SCENE.
