ON 05-08-2020 AT APPROXIMATELY 06;08 A.M. RECEIVED CALL FROM BULLOCH COUNTY 911 TO RESPOND TO 43 ARCHIE MITCHELL ROAD IN REFERENCE TO A BLACK MALE SUBJECT SAYING SOMEONE WANTS TO HURT HIM, THERE IS A LANGUAGE BARRIER. UPON ARRIVAL SAW A BLACK MALE STANDING IN THE FRONT YARD, A BLACK MALE WITHOUT A SHIRT STANDING ON THE LEFT SIDE OF THE PORCH AND TWO BLACK MALES STANDING ON THE RIGHT SIDE OF THE PORCH. THE BLACK MALE IN THE YARD WAS APPROACHING MY PATROL VEHICLE. UPON GETTING OUT OF MY PATROL VEHICLE THE BLACK MALE WAS TRYING TO COMMUNICATE WITH ME TALKING VERY EXCITED AND FAST, I COULD NOT UNDERSTAND HIM OR THE LANGUAGE HE WAS SPEAKING. I TOLD THE BLACK MALE TO GO SIT DOWN SEVERAL TIMES ON THE PORCH STEPS ATTEMPTING TO CREATE DISTANCE AND POSSIBLY CALM HIM DOWN. THE BLACK MALE DID NOT COMPLY. I ASKED THE BLACK MALE WITHOUT A SHIRT TO TELL MOHAMED TO SIT ON THE PORCH STEPS. AFTER SEVERAL MINUTES AND THEM RAISING THEIR **VOICES MOHAMED FINALLY** SAT ON THE PORCH STEPS. I ASKED THE BLACK MALE WITHOUT A SHIRT ON IF HE COULD EXPLAIN TO ME WHAT WAS GOING ON THIS MORNING AND HE STATED THAT THEY ALL WORK AT THE CLAXTON POULTRY PLANT, TODAY WAS MOHAMED'S FIRST DAY AT WORK AND WHEN MOHAMED CAME HOME HE STARTED BEATING ON ALL THEIR DOORS KEEPING THEM AWAKE AND WOULD NOT LET THEM SLEEP OR REST, MOHAMED KEPT TELLING THEM SOMEONE WAS OUTSIDE AND GOING TO GET HIM, MOHAMED HAS BEEN ACTING CRAZY SINCE HE GOT HOME FROM WORK. THE BLACK MALE WITHOUT A SHIRT ON STATES THEY WERE ALL MAD AT MOHAMED AND MOHAMED WAS EVEN BEATING AND KNOCKING ON THE NEIGHBORS DOOR. AT THIS TIME MOHAMED AND THE BLACK MALE WITHOUT A SHIRT ON WAS RAISING THEIR VOICES, MOHAMED GOT UP OFF OF THE STEPS AND STATED THEY GOING TO KILL ME! THE NEIGHBOR A VERY CLEAN CUT WELL DRESSED BLACK MALE WALKED OVER TO WHERE WE WERE . I ASKED THE NEIGHBOR IF HE COULD SPEAK ENGLISH? HE SPOKE ENGLISH VERY WELL AND STATES HE COULD TRANSLATE. THE TRANSLATOR TOLD ME THAT ALL FOUR OF THEM STAYED IN THE APARTMENT AND EACH HAD THEIR OWN ROOM THAT THEY COULD LOCK, THE MOHAMED WAS KEEPING THEM ALL AWAKE BEATING ON THEIR DOORS, THAT MOHAMED WAS IN THE HOSPITAL IN ATLANTA NINE DAYS AGO FOR AMMONIA IN HIS BLOOD AND GOT IV'S IN HIS ARM. MOHAMED GOT OFF THE STEPS AGAIN AND SAID THEY GOING TO KILL ME, I DO NOT LIKE AMERICA I WANT TO GO TO SUDAN YOU TAKE ME TO AIRPORT. I THEN ADVISED THE TRANSLATOR TO TELL ALL OF THEM TO GO TO CLAXTON POULTRY TODAY HUMAN RESOURCES AND TELL THEM WHAT'S GOING ON SO MABY THEY CAN HELP HIM THAT THEY HAD A CLINIC AND NURSES THERE AND A TRANSLATOR. I THEN TOLD MOHAMED I COULD NOT TAKE HIM TO THE AIRPORT. TWO OF THE BLACK MALES ON THE PORCH WENT INSIDE TO GO TO BED. THE TRANSLATOR WAS TALKING TO MOHAMED. MOHAMED HAD PAPERS IN HIS HAND SUPPOSEDLY FROM THE HOSPITAL. I ASKED MOHAMED IF HE WANTED TO GO TO THE HOSPITAL AND ADVISED HIM I COULD CALL E.M.S. MOHAMED STATES CALL THEM TO TAKE ME TO THE AIRPORT, AGAIN I ADVISED MOHAMED THAT THEY COULD ONLY TAKE HIM TO THE HOSPITAL TO SEE A DOCTOR. MOHAMED HAD BROKEN ENGLISH AND WOULD SPEAK SOME ENGLISH AND ANOTHER LANGUAGE MIXED TOGETHER THE TRANSLATOR WAS TRANSLATING TO ENGLISH WHAT MOHAMED WAS TRYING TO COMMUNICATE TO ME WHEN I DID NOT UNDERSTAND. MOHAMED WAS SWEATING, VERY NERVOUS, SEEMED SCARED, DISPLAYED ERRATIC BEHAVIOR AND WOULD NOT STAND STILL, AT TIMES RAISING HIS VOICE ACTING PARTICULAR.
