NOLLAN WAS PROMOTING MARSH CONSTRUCTION. SCREEN SHOTS OF THE CONVERSATION WERE POSTED ON FACEBOOK THROUGH VARIOUS SOURCES.

WHEN MR. TRAVIS MARSH ARRIVED HE ADVISED ME THAT HE HAD RECEIVED SEVERAL CALLS AND A TEXT FROM VARIOUS NUMBERS PERTAINING TO THE SITUATION. MR. TRAVIS ADVISED THAT HE SPOKE TO ONE FEMALE WHO CALLED HIM. THE FEMALE ASKED WHAT WAS GOING TO BE DONE. MF TRAVIS ADVISED THAT HE TOLD THE FEMALE THAT MR. NOLLAN WAS TERMINATED EFFECTIVE IMMEDIATELY AND THAT IF SHE COULD DO ANYTHING TO HELP COOL THE SITUATION, AND THEY WOULD APPRECIATE IT. THE FEMALE WENT ON FACEBOOK MOCKING MR. TRAVIS SAYING THAT IT WAS NO' GONNA HAPPEN. " THERE IS NO COOLING. ITS SUMMER TIME! THE BLOCK IS HOT." AS WELL THAT SHE IS GOING TO HYPE UP THE SITUATION RATHER THAN COOL IT.

MR. TRAVIS ADVISED ME THAT, THEY DID WRITE A STATEMENT ON FACEBOOK SHOWING THAT MR. NOLLAN WAS TERMINATED EFFECTIVE IMMEDIATELY AND THAT THEY WERE NOT INVOLVED. MR. NOLLAN ADVISED THAT HE WAS TOLD THAT THERE WERE POST ON FACEBOOK ABOUT PEOPLE FINDING OUT THE OWNERS OF THE COMPANY AND SHOOTING UP THE PLACE. NO POSTS OF SORTS COULD BE FOUND AT THE TIME. I ADVISED MR.
