MS. MATTIE CONTINUED TO STATE THAT AN ATM WITHDRAWAL FROM A CORE CREDIT UNION IN AN UNKNOWN LOCATION WAS MADE FROM HER ACCOUNT IN THE AMOUNT OF \$300.00. MS. MATTIE STATED THAT SHE DID NOT AUTHORIZE THIS WITHDRAWAL.

MS. MATTIE HAS CONTACTED BB&T AND ADVISED THEM ABOUT THE FRAUDULENT ACTIVITY. THIS REPORT IS DOCUMENTATION FOR MS. MATTIE TO PROVIDE TO HER BANKING INSTITUTION FOR THEIR INTERNAL INVESTIGATION. NOTHING FURTHER AT THIS TIME.
