ON 7/7/2020 AT 17:25 I MET WITH MR. MARKS REGARDING A BOAT MOTOR THAT WAS STOLEN. HE STATED THE MOTOR WAS ATTACHED TO A 16FT ALUMINUM JOHN BOAT THAT IS TIED UP AT THE END OF HIS DOCK. HE SAW THE MOTOR ON THE BOAT AT APPROXIMATELY 8PM ON 7/5/2020. THE NEXT DAY 7/6/2020 AROUND 11AM WHEN HE GOT HIS JUVENILE DAUGHTER TO CHECK TO MAKE SURE THE RAIN HAD NOT FILLED UP THE BOAT WITH WATER, SHE TOLD HIM IT WAS MISSING. ON 07/07/2020 AT APPROXIMATELY 1944 HOURS I WAS DISPATCHED TO THE LISTED LOCATION IN REFERENCE TO A BURGLARY. I ARRIVED AT THE LOCATION AND MADE CONTACT WITH THE COMPLAINANT, WHO STATED HE HAD BEEN OUT OF TOWN WORKING FOR A COUPLE WEEKS AND UPON RETURNING HAD FOUND THAT SOMEONE HAD BURGLARIZED HIS HOME AND TAKEN MULTIPLE ITEMS. AFTER RECEIVING THIS INFORMATION, THE CASE WAS TURNED OVER TO CID FOR FURTHER INVESTIGATION.

**INCIDENT NARRATIVE:**

ON THE ABOVE DATE AND TIME, I RESPONDED TO A CALL IN REFERENCE TO A DOMESTIC DISPUTE. UPON MY ARRIVAL, I MET WITH THE COMPLAINANT WHO STATED THAT SHE AND HER HUSBAND HAD RECENTLY GOTTEN INTO AN ARGUMENT ABOUT A CHECK. SHE STATED THAT HE BECAME UPSET WITH HER AFTER NOT BEING ABLE TO FIND A CHECK HE HAD. SHE ALSO STATED THAT DURING THE EXCHANGE HE WAS ATTEMPTING TO GET HER TO HIT HIM SO THAT HE COULD HIT HER BACK. THE COMPLAINANT ALSO MADE ME AWARE THAT HER HUSBAND SUFFERS FROM BIPOLAR DISORDER AND THAT HIS MEDICINE HAS NOT BEEN RIGHT AND THEY WERE ATTEMPTING TO GET IT RIGHT WITH THE DOCTORS.

I WAS ABLE TO SPEAK WITH THE OFFENDER WHO WAS ABLE TO CORROBORATE THAT THE ARGUMENT WAS OVER A CHECK. HE STATED THAT HE ASKED HER WHERE A CHECK HE WROTE HAD WENT WHERE HE STATED SHE SAID SHE DIDN'T KNOW. AN ARGUMENT ENSUED BETWEEN THE TWO SHORTLY AFTER THIS. HE STATED THAT SHE GOT IN HIS FACE AND HE STATED THAT IF SHE WERE TO HIT HIM HE WOULD HIT HER BACK BUT THAT DID NOT HAPPEN.

WHILE ON SCENE, I WAS NOT ABLE TO OBSERVE ANY PHYSICAL EVIDENCE OF A CRIME COMMITTED WITH EITHER PARTY OR ANY PROPERTY DAMAGE. AFTER SPEAKING WITH BOTH PARTIES THEY STATED THEY WOULD LEAVE EACH OTHER ALONE AND COOL OFF BEFORE SPEAKING TO ONE ANOTHER AGAIN. I ALSO ADVISED BOTH PARTIES TO CALL LAW ENFORCEMENT IF ANY OTHER PROBLEMS AROSE. REPORT FOR DOCUMENTATION.
