INCIDENT NARRATIVE:

After the other unit arrived on scene, I asked Ms. Valchine if there was any marijuana in the vehicle. She then told me "yes" and showed me a black bag where it would be. I then had Ms. Valchine step out of the vehicle and I conducted a probable cause search.

During the search I located in the black bag that Ms. Valchine was referring to, with a glass jar of a green leafy substance suspected to be marijuana and a green smoking device. I then continued the search where there was a camouflage suitcase with locks on it. Ms. Valchine was asked it she could open the suitcase which she did and after going through the suitcase there was a baggy with 6 multiple colored pills suspected to be ecstasy. Ms. Valchine stated that her dealer where she gets her marijuana from gave her the pills.

I then placed Ms. Valchine under arrest and transported her to the Bulloch County Jail on the above listed charges. I issued a citation to Ms. Valchine for the tag light violation and everything else was turned over to CST where they will issue warrants for Ms. Valchine. Ms. Valchine's vehicle was left at the scene. Nothing further.

I LEFT THE RESIDENCE AND SEARCHED FOR MR FRENCH IN THE DIRECTION THAT MS STEWART HAD TOLD ME HE HAD GONE WALKING. I CAME UP ON MR FRENCH ON DELOACH CHURCH RD JUST BEFORE MARTIN RD, WHERE I GOT OUT AND TALKED WITH MR FRENCH. MR FRENCH APPEARED TO BE UNDER THE INFLUENCE OF ALCOHOL AND WAS VERY UPSET. WHILE TALKING WITH MR FRENCH, HE STATED THAT HE WAS JUST UPSET DUE TO SOME PREVIOUS FAMILY ORDEALS AND WOULD LEAVE MR STEWART AND MS STEWART ALONE.

I TOLD MR FRENCH THAT HE WAS NOT ALLOWED BACK ON THE PROPERTY OF 1898 DELOACH CHURCH RD AND THAT HE HAD BEEN CRIMINALLY TRESPASSED FROM THE PROPERTY. MR FRENCH WAS ADVISED THAT IF HE WERE TO RETURN TO THE PROPERTY HE WOULD BE ARRESTED.

MR FRENCH WAS RELEASED AND CONTINUED ON FOOT DOWN DELOACH CHURCH RD WITHOUT ANY FURTHER INCIDENTS.
