ON 09/28/2020 I SPOKE WITH MR. JOHN PRESSEY VIA TELEPHONE IN REFERENCE TO LOST/MISLAID PROPERTY.

MR. PRESSEY STATED THAT HE LAST SAW THE LISTED FIREARM WHILE HE HAD IT ON HIS PERSON ON OR ABOUT 09/06/2020 AT THE INCIDENT LOCATION MR. PRESSEY BELIEVES HE MAY HAVE PLACED THE FIREARM SOMEWHERE TO KEEP IT SAFE FROM CHILDREN AND DOES NOT KNOW WHERE IT WAS PLACED.

MR. PRESSEY STATED THAT HE HAS CONDUCTED A VERY THOROUGH SEARCH PRIOR TO MAKING THIS REPORT AND HAS BEEN UNABLE TO LOCATE THE FIREARM. THE FIREARM WILL BE ENTERED INTO G.C.I.C. AS LOST/MISLAID.

INCIDENT NARRATIVE:

ON 09/28/2020 AT APPROXIMATELY 1148 HOURS I MET WITH THE COMPLAINANT, TINA SHOTTON, AT 1123 SOUTHBEND DRIVE APT B IN REFERENCE TO THREATS.

SHOTTON SAID HER BOYFRIEND'S SISTER, NYKOLE POTTS, TEXT MESSAGED HER THAT SHE WAS GOING TO COME TO THE RESIDENCE AND FIGHT HER. UPON FURTHER INVESTIGATION I READ THE TEXT MESSAGES ON SHOTTON'S PHONE BETWEEN HER AND POTTS. I FOUND THAT THE THREATS TO FIGHT WERE MUTUAL BY BOTH PARTIES.

WHEN I ASKED SHOTTON WHAT SHE AND POTTS WERE ARGUING ABOUT, SHOTTON SAID THAT POTTS IS ANGRY ABOUT HER DATING HER BROTHER. SHOTTON ALSO MENTIONED THAT SHE CALLED DFACS ON POTTS FOR SMOKING MARIJUANA AROUND CHILDREN. SHOTTON DID NOT HAVE DETAILED INFORMATION ON POTTS. SHOTTON ONLY KNEW THAT POTTS LIVED ON FRANKLIN ROAD, BUT HAD NO NUMERICAL ADDRESS. SHE WAS UNABLE TO GIVE POTTS' DATE OF BIRTH OR PROPER SPELLING OF HER NAME.

I ADVISED SHOTTON TO BLOCK POTTS ON HER PHONE, AND TO MAKE ALL OF HER SOCIAL MEDIA ACCOUNTS PRIVATE. I TOLD SHOTTON NOT TO COMMUNICATE WITH POTTS AND TO CALL 911 IF SHE CAME ONTO HER PROPERTY. I PULLED A CASE NUMBER FOR A CIVIL MATTER UPON SHOTTON'S REQUEST. THE CASE IS CURRENTLY INACTIVE.

ON 09/28/2020 I SPOKE WITH MS. DESIREE SMITH VIA TELEPHONE IN REFERENCE TO AN OVERDUE MOTORIST.

MS. DESIREE STATED THAT SHE RECENTLY PURCHASED A 2002 CHEVROLET CAVALIER. SOON AFTER PURCHASE SHE ALLOWED MS. JENNIFER WIGGINS TO BORROW THE VEHICLE (PRIOR TO HAVING REGISTRATION OR INSURANCE ON IT) AND "DRIVE RIGHT DOWN THE ROAD" TO MS. WIGGINS' FATHER'S HOME.

MS. SMITH STATED THAT MS. WIGGINS DOES NOT HAVE A PHONE AND SHE COULD NOT PROVIDE AN ADDRESS FOR HER HOWEVER, STATED THAT SHE HAS HEARD FROM MS. WIGGINS' COUSIN THAT SHE IS PLANNING ON BRINGING THE VEHICLE BACK SOON.

MS. SMITH WAS ADVISED THAT A REPORT WOULD BE ON FILE FOR AN OVERDUE MOTORIST. SHE WAS ALSO ADVISED THAT IF MS. WIGGINS DOES NOT RETURN THE VEHICLE BY 10/02/2020 TO CONTACT LAW ENFORCEMENT SO THAT CONTACT COULD BE ATTEMPTED AT THE ADDRESS WHERE MS. WIGGINS TOOK THE VEHICLE (SHE STATED THAT SHE COULD POINT OUT THE LOCATION BUT WAS UNABLE TO PROVIDE AN ADDRESS).

IT IS NOT BELIEVED THAT MS. WIGGINS' IS IN ANY DANGER. REPORT FOR DOCUMENTATION AT THIS TIME.

INCIDENT NARRATIVE:

ON 09/28/2020, I DEPUTY R. SHAFER WAS DISPATCHED TO HIGHWAY 24 AT MACEDONIA ROAD, TO ASSIST A GEORGIA STATE TROOPER WITH A TRAFFIC STOP. WHEN I ARRIVED STATE TROOPER HAMMOND WAS ON SCENE WITH THE OFFENDER, MR. JOSEPH CUTRO. TROOPER HAMMOND ADVISED ME THAT MR. CUTRO HAD MARIJUANA IN HIS VEHICLE AND NEEDED MY ASSISTANCE. BEFORE SEARCHING THE VEHICLE, I ASKED MR. CUTRO HOW MUCH MARIJUANA HE HAD IN HIS VEHICLE. MR. CUTRO ADVISED BETWEEN 6-7 GRAMS WORTH OF MARIJUANA. I ASKED MR. CUTRO WHERE THE MARIJUANA WAS LOCATED. MR. CUTRO ADVISED THAT THE MARIJUANA WAS LOCATED IN THE CENTER CONSOLE OF HIS VEHICLE.

TROOPER HAMMOND HANDLED THE MARIJUANA, CONDUCTED A FIELD SOBRIETY TEST ON MR. CUTRO AND THEN PLACED MR. CUTRO UNDER ARREST FOR POSSESSION OF MARIJUANA, SPEEDING, AND DUI LESS SAFE.

I TRANSPORTED MR. CUTRO TO THE BULLOCH COUNTY JAIL FOR TROOPER HAMMOND, WHILE TROOPER HAMMOND WAITED FOR A&P WRECKER SERVICE TO TOW THE VEHICLE.
