**INCIDENT NARRATIVE:**

On 09/03/2020 at 1919 hours I took a report over the phone for Harassing Communications. The complainant was a Mrs. Michelle Collins, Collins stated that she had received several phone calls from an inmate at the Effingham County Jail. She didn't accept the charges, but she knows that Howard Granger is an inmate there he and she has custody of his daughter Rainey.

Collins received custody of the child when it was awarded to her by DFACS because Granger was arrested. The child's mother a Tiffany Miller was found to have been neglecting the child, due to the child being under weight and not socialized at all because the baby was left in a room most of the time by herself.

I spoke with the Effingham County Jail's Booking Desk, The Corporal in charge said that she saw that Granger made thirty phone calls and fifteen were to Michelle Collins phone. The only way that Granger could have received that information was most likely from Tiffany Miller, The Effingham Jail blocked that number so Granger couldn't call it anymore. I then contacted the Effingham County Sheriff Office to go make contact with the mother Tiffany Miller at 680 Griffin Lake Road in Guyton, to inform her to have no further interaction with Mrs. Collins. They said that they would first thing in the morning, I instructed Collins to let DFACS know if she in contacted anymore or harassed in anyway so it can be added to the report.
