INCIDENT NARRATIVE:

ON THE ABOVE DATE AND TIME, I RESPONDED TO A CALL IN REFERENCE TO A UNGOVERNABLE CHILD. UPON MY ARRIVAL, I MET WITH THE COMPLAINANT WHO STATED HER JUVENILE DAUGHTER WAS REFUSING TO GIVE HER PHONE BACK. THE JUVENILE GAVE THE PHONE BACK ONCE WE WERE ON SCENE. THE COMPLAINANT ADVISED THAT HER DAUGHTER WAS DEALING WITH A MENTAL ILLNESS AND HAS BEEN ACTING OUT. SHE STATED THAT SHE HAS SPOKE WITH DFACS AND THE SCHOOL COUNSELORS BECAUSE HER DAUGHTER HAS ACCUSED HER OF PUTTING HER HANDS AROUND HER NECK BUT SHE STATED THIS NEVER HAPPENED. SHE WAS ATTEMPTING TO TAKE HER PHONE DUE TO HER BEHAVIOR.

I THEN SPOKE WITH THE OFFENDER WHO STATED THAT SHE AND HER MOTHER GOT INTO AN ARGUMENT ABOUT THE PHONE BECAUSE SHE FELT AS THOUGH SHE NEEDED TO ASK HER DAD IF SHE COULD TAKE IT BECAUSE HE PAYS FOR IT. WHILE SPEAKING WITH HER, SHE STATED THAT SHE DOES NOT LIKE LIVING HERE AND WANTED TO GO BACK TO MAINE TO LIVE WITH HER FATHER AND THE REST OF THE FAMILY. SHE ALSO STATED THAT HER MOTHER IS OFTEN MEAN TO HER AND MISTREATS HER WHICH LED HER TO TALK TO THE SCHOOL COUNSELOR.

THE COMPLAINANT ADVISED THAT THEY WERE ALREADY IN THE PROCESS OF GETTING THE JUVENILE SOME HELP. SHE STATED THEY HAD A PINELAND APPOINTMENT SCHEDULED AND ALSO THERAPY SESSIONS. REPORT FOR DOCUMENTATION.

INCIDENT NARRATIVE:

On September 18, 2020 at approximately 1744 hours I, Corporal Juarez, responded to 1262 Brooklet South Drive in reference to a physical dispute. Upon arrival I met with the complainant, Jessica Hightower, who stated she was assaulted by her sister, known as Anna Rimsek. Jessica stated that she invited Anna to her residence to discuss a matter of family estates, and she described the estates to be an ongoing disagreement between the family.

When Anna arrived, they began discussing the matter outside the residence and it escalated into a verbal altercation. According to Jessica, both she and Anna began raising their voices, and Jessica stated that she was talking and moving her hands during conversation. Jessica stated that she did step towards Anna, but it wasn't in a violent manner. When Jessica stepped towards her, Anna then struck Jessica on the left side of her facial area. Both Jessica and Anna then engaged in a physical altercation, which led to both parties receiving superficial injuries.

Jessica stated that her husband, Dustin Hightower, was inside the residence when the incident occurred, and when he heard the commotion, he immediately rushed to separate both parties. Dustin then forced Anna to leave the residence, and then notified law enforcement, but Anna had already left the residence upon Deputies arrival.

After discussing the matter with Jessica, I then informed her that I would make contact with Anna so that she could have an opportunity to give a statement on what occurred. I did speak with Anna via phone, and she was able to give her statement.

Anna stated that Jessica informed her that she could come their residence to discuss the family estate. Their conversation began outside of the residence and then escalated into a verbal altercation. Anna stated that Jessica began moving her hands aggressively while she was talking, and Jessica lunged towards her aggressively. Anna perceived Jessica's act to be a threat, therefore, Anna swung at Jessica and struck her in the face. Anna stated that they both engaged in a physical confrontation, and Jessica ripped her shirt and scratched her on several areas of her body. Dustin then intervened by separating them, and then forced Anna to leave the residence.

While investigating the incident, it was discovered that both Jessica and Anna are siblings who formally resided in the same residence (not current residence). During the physical altercation, Jessica received a visible injury (bruising) on the left side of her face and forehead, and Anna received several scratch marks on her body and her shirt was ripped. As I spoke with both parties, it appears that both parties perceived each other's behavior as a threat, which led to both of them engaging in a physical altercation. Both individuals stated that they felt as if they should defend themselves during the encounter.

After further investigation, and after receiving both statements, it appears that a primary aggressor could not be identified. The involved parties are siblings and the act committed is consistent with the offense of simple battery. Due to the fact that the involved parties are siblings and a primary aggressor could not be identified, the parties were referred to Magistrate Court if they felt the need to pursue criminal charges. Furthermore, a criminal trespass warning was given to Anna for the residence of 1262 Brooklet South Drive, per the request of Dustin and Jessica.

ANN STATED THAT THE THIRD BUILDING OF THE PROPERTY SOMEONE HAD OPENED THE FRONT DOOR AND BUSTED DOWN THE SIDE DOOR.

UPON ARRIVAL OF THE THIRD BUILDING I, DEPUTY BARRICK AND OTHER BULLOCH COUNTY SHERIFF OFFICE DEPUTIES CLEARED THE PREMISES AND MADE SURE NO ONE WAS INSIDE. AFTER CLEARING THE BUILDING THERE WAS NO ONE INSIDE THE PREMISES. ANN THEN WENT THROUGH THE BUILDING TO SEE IF ANYTHING WAS TAKEN. ANN STATED THAT NOTHING WAS TAKEN FROM THE BUILDING BUT ITEMS WERE REMOVED FROM A BOX AND A DESK DRAWER AS IF SOMEONE WAS LOOKING FOR SOMETHING. I, DEPUTY BARRICK NOTICED THE KEY PAD LOCK ON THE SIDE DOOR HAD BEEN STRUCK WITH A HAMMER OR SCREW DRIVER, THE DOOR WAS ALSO PUSHED IN.

AFTER EXITING THE THIRD BUILDING I, DEPUTY BARRICK WENT BACK TO THE MAIN RESIDENCE AND HAD ANN WALK THROUGH THE PREMISES AND SEE IF ANYTHING WAS MISSING OR DAMAGED. ANN STATED THAT EVERYTHING WITHIN THE PREMISES WAS STILL THERE AND THAT NOTHING HAD BEEN TAKEN BUT THE DEADBOLT FOR THE DOOR ON THE C SIDE HAD BEEN STRUCK WITH A HAMMER OR SCREW DRIVER. I, DEPUTY BARRICK ALSO NOTICED A BRICK BY THE B SIDE DOOR THAT WAS USED TO SMASH OUT THE WINDOW. ANN WAS ASKED BY A BULLOCH COUNTY SHERIFF OFFICE DEPUTY IF ALL BUILDINGS WERE UNDER ONE ADDRESS AND ANN STATED THEY WERE. I, DEPUTY BARRICK LATER DETERMINED THAT THIS WAS A CRIMINAL TRESPASS DAMAGE TO PROPERTY. ANN STATED SHE DOES NOT KNOW WHO COULD HAVE DONE THE DAMAGE BECAUSE THERE ARE MANY PEOPLE THAT WALK THROUGH THE AREA.

THE COMPLAINANT ADVISED ME THAT SHE OWNS THE MAD POTTER FLOWER SHOP AND THEY HAVE AN EMPLOYEE THAT THEY BELIEVE HAS BEEN STEALING FROM THEM. THE COMPLAINANT ADVISED THAT WHILE SHE WAS ATTEMPTING TO DO HER AUDIT, SHE NOTICED IT WAS NOT COMING OUT RIGHT AND BELIEVES THAT AN EMPLOYEE HAD BEEN STEALING ITEMS AND POSSIBLY MONEY.

THE COMPLAINANT ADVISED THE OFFENDER AND HER BOYFRIEND (LISTED AS OTHER) HAD RECENTLY BROKEN UP AND THEY SPOKE WITH HER EX-BOYFRIEND. WHEN THE COMPLAINANT ASKED ABOUT HER ITEMS, THE EX-BOYFRIEND STATED THERE WERE SOME ITEMS AT HIS HOUSE BUT HE WAS UNAWARE IF SHE HAD ACTUALLY STOLEN THEM OR BEEN GIVEN THEM OR PAID FOR THEM. THE COMPLAINANT ADVISED HER, AND HER HUSBAND WENT TO THE EX-BOYFRIENDS RESIDENCE WHERE THEY WERE ABLE TO LOCATE SOME OF THEIR ITEMS FROM THE SHOP. THEY TOOK PICTURES OF THE ALLEGED STOLEN ITEMS. THE COMPLAINANT ADVISED THAT THE OFFENDER HAD BEEN WORKING FOR THEM SINCE MARCH SO THEY WERE UNAWARE OF AN ACTUAL TIME FRAME OF THE ITEMS BEING STOLEN. SHE ADVISED THAT THE VALUE OF ALL THE THINGS TAKEN WERE APPROXIMATELY \$600. AT THIS TIME, THE COMPLAINANT ASKED IF I COULD GO TO THE EX-BOYFRIEND'S ADDRESS TO SPEAK WITH HIM AND TO OBSERVE THEIR ITEMS.

WHEN I ARRIVED AT THE OFFENDER'S EX-BOYFRIEND'S RESIDENCE, I WAS ABLE TO SPEAK WITH HIM IN REFERENCE TO THE MATTER. HE STATED THAT SHE HAD A LOT OF THINGS IN THE BACKYARD. HE STATED HE WOULD ALWAYS NOTICE HER BRING ITEMS HOME BUT WAS UNAWARE OF THE MEANS SHE OBTAINED THEM. HE STATED HE NEVER ASKED HER ABOUT THE ITEMS OR SHE SAID ANYTHING ABOUT THEM. I WAS ABLE TO PHOTOGRAPH THE ITEMS AFTER THEY WERE POINTED OUT TO ME.

I THEN RETURNED TO THE COMPLAINANT'S RESIDENCE TO FURTHER SPEAK WITH THEM. I ASKED WHAT DID SHE WANT TO HAPPEN IN THIS SITUATION AND SHE STATED SHE SIMPLY WANTED TO BE REIMBURSED FOR THE ITEMS TAKEN AND ALSO THE POSSIBLE STOLEN MONEY SO THAT SHE COULD HAVE HER AUDIT DONE CORRECTLY. SHE STATED SHE DID NOT WANT THE ITEMS IN QUESTION AS WELL. SHE STATED SHE ALSO WANTED THE OFFENDER SERVED WITH CRIMINAL TRESPASS FROM THE SHOP. BEFORE I WENT TO SERVE THE OFFENDER WITH CRIMINAL TRESPASS, I QUESTIONED THE COMPLAINANT AS TO WHETHER OR NOT THE OFFENDER WAS NO LONGER EMPLOYED AND HAD BEEN MADE AWARE OF THIS. SHE STATED SHE NO LONGER WANTED HER TO WORK FOR HER BUT HAD NOT NOTIFIED HER. WITH THAT BEING KNOWN, I ADVISED THE COMPLAINANT THAT TO PREVENT CONFUSION ON WHETHER OR NOT THE OFFENDER IS WELCOMED AT THE SHOP, SHE SHOULD VERBALLY ADVISE HER SHE NO LONGER HAD A JOB. WHILE ON SCENE, THE COMPLAINANT WAS ABLE TO DO THIS WITH THE OFFENDER WHERE I THEN SERVED THE OFFENDER WITH CRIMINAL TRESPASS VIA TELEPHONE.

IN REGARDS TO THE MONEY THE COMPLAINANT WISHED TO BE REIMBURSED FOR, I ADVISED THE COMPLAINANT THAT SHE COULD ASK THE OFFENDER TO DO SO OR IF THAT DIDN'T WORK SHE WOULD HAVE TO GO THROUGH THE MAGISTRATE COURT.
