INCIDENT NARRATIVE:

I responded to the listed incident location in reference to a suspicious male walking in and out of traffic on the highway. Upon arrival, I located the male Mr. K. Freeman (listed offender), just passed mile marker 118. Mr. K. Freeman stated he was walking from Gainesville Georgia to an unknown location. I asked Mr. K. Freeman if he would like a ride to the nearest town or to the next county to a town closer to Savannah Georgia. Mr. K. Freeman agreed to the ride down the highway to the next county. I told Mr. K. Freeman we would have to search his belonging as well as himself to insure the safety of him and myself before transporting Mr. K. Freeman in the patrol vehicle. Mr. K. Freeman agreed to the search.

I was assisted by Deputy J. Partlow, to conduct the search of Mr. K. Freeman's belongings as well as himself. During the investigation of Mr. K. Freeman's bag a small notebook was discovered, which Mr. K. Freeman called his diary? While Deputy J. Partlow was searching the notebook for any equipment that could harm us i.e. razor blades, needles etc., Mr. K. Freeman showed signs of irritation and began trying to take the notebook from Deputy J. Partlow. Mr. K. Freeman reached for the notebook multiple times and stated he was going to show us a razor. Deputy J. Partlow removed Mr. K. Freeman's hand from the notebook when he reached for it again and Mr. K. Freeman was placed in handcuffs without incident.

Mr. K. Freeman was transported to the Bulloch County Sheriff's Office Jail for booking and processing on Obstruction of Law Enforcement Officer O.C.G.A. 16-10-24(a), and Pedestrian in Roadway O.C.G.A. 40-6-96.

I RESPONDED TO 2608 RIVERBEND ROAD OFF OF OLD RIVER ROAD NORTH AND MET WITH A ROZ DANIEL AT THAT ADDRESS IN REFERENCE TO A NEIGHBOR THAT SHE STATES CONTINUES TO COME ON HER PROPERTY. ROZ DANIEL EXPLAINED THAT HER NEIGHBOR THAT RESIDES AT 2800 RIVER BEND ROAD, COMES ON HER PROPERTY, BECAUSE SHE IS A CENCUS TAKER. MRS. ROZ STATES, THAT SHE HAS EXPLAINED TO THE ELDERLY LADY, THAT SHE HAS MAILED IN HER CENCUS, AND HAS ASKED HER TO PLEASE NOT RETURN TO THE RESIDENCE. MRS. ROZ HAS CAUGHT HER ON CAMERA AT THE RESIDENCE WHEN SHE WAS NOT AT HOME. MRS. ROZ DANIEL EXPRESSED TO ME THAT SHE WISHES FOR THE ELDELY LADY TO NOT COME BACK TO HER PROPERTY, SHE IS WORRIED THAT SHE MAY FALL, SHE EXPLAINED THE UNSTEADY WALK OF THE NEIGHBOR. ROZ DANIEL EXPLAINED IS CONCERNED ABOUT A POSSIBLE LAW SUIT FROM THE NEIGHBOR IF SHE WERE TO FALL AND HURT HERSELF. ROZ DANIEL HAS POSTED SIGNS CLEARLY VISIBLE ON HER PROPERTY.

I LEFT 2608 RIVERBEND ROAD AND WENT TO THE 2600 RIVERBEND ROAD ADDRESS AND MET WITH MRS. BETTY PATTY. MRS. PATTY CAME TO THE DOOR WITH PHONE IN HAND AND EXPRESSED TO ME THAT SHE KNEW WHY I WAS THERE , AND I NEEDED TO TALK TO HER BOSS. I INFORMED MRS. PATTY THAT I WOULD TALK TO HER BOSS, BUT I WANTED TO TALK TO HER FIRST. MRS. BETTY PATTY WAS INFORMED THAT SHE WAS NOT WELCOMED AT THE ADDRESS OF 2608 RIVERBEND ROAD, THAT SHE WAS SERVED CRIMINAL TRESPASS FOR THE RESIDENCE. SHE HAD BEEN EXPLAINED THIS ON TWO OTHER OCCAISIONS BY BULLOCH COUNTY DEPUTIES. MRS. BETTY EXPLAINED THAT SHE WAS ONLY DOING WHAT SHE WAS TOLD. I DONT BELIEVE THAT THE CENCUS BUREAU HAD ANY IDEA THAT SHE HAD BEEN SERVED CRIMINAL TRESPASS FOR THE ADDRESS.

I TALKED TO MRS. PATTY'S BOSS ON MRS. PATTY'S PHONE, SHE OVERHEARD THE COMPLETE CONVERSATION. SHE STATED THAT SHE WOULD MAKE A NOTE OF THE FACT THAT MRS. PATTY WASN'T TO RETURN TO THE RESIDENCE.

BURNEY ADVISED ME THAT A GUY BY THE NAME OF DAVID TOLBERT WAS HARASSING HER ON FACEBOOK, TIKTOK AND TWITTER. MS. BURNEY ADVISED THAT THIS IS NOT THE FIRST TIME MR. TOLBERT HAS HARASSED HER. MS. BURNEY STATED THAT HER PROFILE ON FACEBOOK KEEPS BEING REPORT AND SHE KNOW THAT MR. TOLBERT IS THE ONE REPORTING IT, FOR NO REASON. MS. BURNEY ADVISED THAT HER NAME ARE NOT IN ANY OF THE POST BUT SHE KNOW THAT THEY ARE DIRECTED TOWARDS HER, THAT SHE HAS HAD FRIENDS CONTACT HER, AND TELL HER THEY ARE ABOUT HER. MS. ON 09/10/2020 AT APPROXIMATELY 1950 HOURS I WAS DISPATCHED TO 2207 TRISTAN AMBER COURT IN REFERENCE TO A UNWANTED PERSON. I ARRIVED AT THE RESIDENCE AND MADE CONTACT WITH ERIN HUDDLESTON. HUDDLESTON STATED THAT HER AND THOMAS SANDERSON WHO SHE IS CURRENTLY DATING AND ALSO SHARE THE RESIDENCE WITH RECEIVED A CALL FROM CHEYANNE SANDERSON SAYING THAT SHE WAS ABOUT TO COME TO THEIR RESIDENCE. HUDDLESTON STATED THAT SHE ADVISED CHEYANNE SANDERSON NOT TO COME TO THE RESIDENCE. HUDDLESTON SAID THAT A SHORT TIME AFTER TELLING CHEYANNE SANDERSON NOT TO COME SHE HEARD SOMEONE BANGING ON THE DOOR. HUDDLESTON SAID SHE OPEN THE DOOR AND SAW IT WAS CHEYANNE SANDERSON AND SHE INSTANTLY STARTED HITTING CHEYANNE SANDERSON. HUDDLESTON STATED A FIGHT ENSUED AND THOMAS SANDERSON INTERVENED AND STOPPED THEM. HUDDLESTON SAID THAT SHE THEN CALLED 911. HUDDLESTON STATED THAT SHE DO NOT WANT CHEYANNE SANDERSON BACK AT THE RESIDENCE.

I BEGAN TO SPEAK WITH THOMAS SANDERSON. THOMAS SANDERSON SAID THAT HE HAS BEEN MARRIED TO CHEYANNE SANDERSON FOR THREE YEARS, BUT SEPARATED FROM HER TWO MONTHS AGO. THOMAS SANDERSON STATED THAT CHEYANNE SANDERSON CALLED HIM AND SAID SHE WAS COMING TO THE RESIDENCE AND HE ADVISED HER NOT TO COME. THOMAS SANDERSON SAID THAT HE THEN HEARD A BANG ON THE DOOR AND HUDDLESTON OPEN IT AND STARTED FIGHTING CHEYANNE SANDERSON. THOMAS SANDERSON STATED THAT HE STOPPED THE FIGHT BY STEPPING IN THE MIDDLE OF THE TWO. THOMAS SANDERSON SAID THAT CHEYANNE SANDERSON THEN GOT INTO HER VEHICLE AND LEFT THE SCENE. THOMAS SANDERSON STATED THAT AFTERWARDS HE RECEIVED A PHONE CALL FROM CHEYANNE SANDERSON FATHER SAYING THAT HE WAS ON HIS WAY TO HURT HIM. AT THE TIME OF MY ARRIVAL CHEYANNE SANDERSON FATHER HAD NOT BEEN TO THE RESIDENCE.

UPON MY ARRIVAL CHEYANNE SANDERSON HAD ALREADY LEFT THE RESIDENCE IN HER VEHICLE. A TRAFFIC STOP WAS CONDUCTED ON CHEYANNE SANDERSON VEHICLE NEAR THE RESIDENCE.

I MADE CONTACT WITH CHEYANNE SANDERSON WHO STATED THAT HER AND THOMAS SANDERSON SEPARATED TWO MONTHS AGO, BUT ARE NOT LEGALLY DIVORCED. CHEYANNE SANDERSON SAID THAT HER AND THOMAS SANDERSON SPOKE ON THE PHONE AND AGREED ON HER COMING TO THE RESIDENCE SO THAT THEY COULD TALK IN PERSON. CHEYANNE SANDERSON STATED THAT SHE KNEW THOMAS SANDERSON HAD A NEW GIRLFRIEND, BUT DID NOT KNOW SHE WOULD BE AT THE RESIDENCE WITH HIM. CHEYANNE SANDERSON SAID THAT SHE KNOCKED ON THE DOOR AND HUDDLESTON OPEN IT AND STARTED HITTING HER. CHEYANNE SANDERSON STATED THAT SHE STARTED FIGHTING BACK AND THOMAS SANDERSON SEPARATED THEM. CHEYANNE SANDERSON SAID THAT SHE GOT INTO HER VEHICLE AND LEFT THE SCENE.

ALL PARTIES INVOLVED WERE ADVISED OF THE MAGISTRATE COURT PROCESS IF THEY WANTED TO PURSUE FURTHER ACTION. CHEYANNE SANDERSON WAS SERVED A VERBAL CRIMINAL TRESPASS WARNING AND WAS ADVISED NOT TO RETURN TO THE RESIDENCE. I PULLED A CASE NUMBER FOR THE INCIDENT AND ADVISED THEM THAT THE REPORT WOULD BE READY IN 3-5 BUSINESS DAYS. THIS CASE IS CURRENTLY INACTIVE.
