## **INCIDENT NARRATIVE:**

ON THE ABOVE DATE AND TIME, I RESPONDED TO A CALL IN REFERENCE TO A THEFT BY SHOPLIFTING. AFTER CALLING THE SHERIFF'S OFFICE, THE WORKER AT THE STORE WAS ABLE TO GIVE OUT A TAG NUMBER FOR THE VEHICLE THAT CAME BACK TO A SILVER HONDA ACCORD. AFTER RIDING THE AREA THE VEHICLE COULD NOT BE LOCATED.

THE COMPLAINANT ADVISED THAT WHILE SHE WAS SHOWING THE UNKNOWN OFFENDER SOME PHONES, SHE NOTICED HE APPEARED TO BE ACTING SUSPICIOUSLY. SHE STATED WHILE SHOWING HIM THE PHONE SHE DID NOT WANT TO LET HIM HOLD BECAUSE SHE THOUGHT HE MAY TAKE IT DUE TO HIS BEHAVIOR. WHEN SHE SHOWED HIM THE FIRST PHONE, SHE STATED HE ASKED ABOUT GETTING A DEAL ON ANOTHER PHONE. THE COMPLAINANT STATED SHE WENT TO THE BACK TO SPEAK WITH THE OWNER ABOUT THE DEAL WHEN SHE HEARD THE CASE SLAM. SHE NOTICED THE OFFENDER THEN SPRINTING OUT OF THE STORE. SHE NOTICED THREE PHONES WERE GONE. THE OWNER OF STORE WAS ABLE TO RUN OUTSIDE TO GET THE TAG NUMBER FOR THE VEHICLE.

I WAS ABLE TO REVIEW THE VIDEO WITH THE OWNER. THE OFFENDER WAS A SLENDER WHITE MALE, APPROXIMATELY 5'7 OR SO, HE HAD SLEEVE TATTOOS ON BOTH ARMS, A BLUE SHIRT, KHAKI SHORTS, A LONG CHAIN NECKLACE, AND AN AMERICAN FLAG PRINT FACE MASK. HE LEFT THE STORE IN A HONDA ACCORD HEADING TOWARD THE BROOKLET AREA. THE STORE OWNER OR EMPLOYEE WERE UNFAMILIAR WITH HIM AND HAD NO IDEA WHO HE WAS.
