**INCIDENT NARRATIVE:**

A TRAFFIC STOP WAS CONDUCTED AFTER I CHECKED A 2007 TOYOTA CAMRY SPEEDING TRAVELING SOUTH ON 67 AT 95 MILES PER HOUR AT THE INTERSECTION OF ANDERSON CEMETERY ROAD. THIS PORTION OF THE NEWLY OPENED 67 IS POSTED AT 55 MILES PER HOUR. THE SPEEDING VEHICLE WAS SEEN APPROACHING A VEHICLE THAT WAS TRAVELING THE SPEED LIMIT AND TRAVELING IN THE SAME LANE SO QUICKLY THAT THE DRIVER OF THE SPEEDING VEHICLE HAD TO SUDDENLY STEER INTO THE OTHER LANE OF TRAFFIC TO AVOID A REAR END COLLISION. I TURNED MY PATROL VEHICLE AROUND AND CONDUCTED A TRAFFIC STOP AT JOHN DANIELS LANE. CONTACT WAS MADE WITH THE DRIVER, IDENTIFIED AS CONSTANCE JADORE DOWDELL BY HER VALID GEORGIA DRIVERS LICENSE. SHE ADMITTED THAT SHE KNEW THAT SHE WAS TRAVELING AS FAST AS SHE WAS.
