On Sunday November 1st, 2020 at or around 18:59 hours I Cpl. Corey Fielding 05 responded to Highway 100 at White Farm Road in reference to a single motor vehicle accident involving a deer. I arrived on scene at or around 19:14 hours and met with the complainant (Lucas McGuire).
