Count Two

The Grand Jurors aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **BORIN KHOUN** with the offense of **THEFT BY TAKING**, in violation of **O.C.G.A. § 16-8-2**, for that the said accused, in the County of Gwinnett and the State of Georgia, on or about November 25, 2020, unlawfully did take money of a value of at least \$5,000.00 but less than \$25,000.00, to wit, \$13,095.54, the property of Donald Stillman, with the intention of depriving this owner of this property, contrary to the laws of said State, the good order, peace, and dignity thereof.

Count Three

The Grand Jurors aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **BORIN KHOUN** with the offense of **THEFT BY TAKING**, in violation of **O.C.G.A. § 16-8-2**, for that the said accused, in the County of Gwinnett and the State of Georgia, on or about November 27, 2020, unlawfully did take money of a value exceeding \$24,999.99, to wit, \$27,324.00, the property of Donald Stillman, with the intention of depriving this owner of this property, contrary to the laws of said State, the good order, peace, and dignity thereof.

Count Four

The Grand Jurors aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **BORIN KHOUN** with the offense of **THEFT BY TAKING**, in violation of **O.C.G.A. § 16-8-2**, for that the said accused, in the County of Gwinnett and the State of Georgia, on or about November 30, 2020, unlawfully did take money of a value of at least \$5,000.00 but less than \$25,000.00, to wit, \$5,000.00, the property of Donald Stillman, with the intention of depriving this owner of this property, contrary to the laws of said State, the good order, peace, and dignity thereof.
