

Senate Bill 458

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act regulating public instruction for the County of Richmond, approved
2 August 23, 1872 (Ga. L. 1872, p. 456), as amended, particularly by an Act approved
3 April 8, 2002 (Ga. L. 2002, p. 3756), so as to change the description of the school board
4 districts; to provide for definitions and inclusions; to provide for the continuation in office
5 of current members; to provide for related matters; to provide for effective dates; to repeal
6 conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act regulating public instruction for the County of Richmond, approved August 23, 1872
10 (Ga. L. 1872, p. 456), as amended, particularly by an Act approved April 8, 2002
11 (Ga. L. 2002, p. 3756), is amended by revising paragraph (2) of subsection (e) of Section 1
12 as follows:

13 "(2) For purposes of electing members of the board of education, the Richmond County
14 School District is divided into ten school board districts. One member of the board shall
15 be elected from each such district. School Board Districts 1, 2, 3, 4, 5, 6, 7, and 8 shall
16 be and correspond to those eight numbered districts described in Appendix A attached

17 to and made a part of this Act and further identified as 'User: SD23 Plan Name:
18 RichmondCCSB-Legis-2022 Plan Type: Local'. School Board Districts 9 and 10 shall
19 be and correspond to those two numbered districts described in Appendix B attached to
20 and made a part of this Act and further identified as 'User: SD23 Plan Name:
21 RichmondCCSB-Legis-super-2022 Plan Type: Local'."

22 **SECTION 2.**

23 Said Act is further amended by revising subsection (f) of Section 1 as follows:

24 "(f)(1) For the purposes of such plan:

25 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
26 provided in the report of the Bureau of the Census for the United States decennial
27 census of 2020 for the State of Georgia. The separate numeric designations in a district
28 description which are underneath a VTD heading shall mean and describe individual
29 Blocks within a VTD as provided in the report of the Bureau of the Census for the
30 United States decennial census of 2020 for the State of Georgia; and

31 (B) Except as otherwise provided in the description of any district, whenever the
32 description of any district refers to a named city, it shall mean the geographical
33 boundaries of that city as shown on the census maps for the United States decennial
34 census of 2020 for the State of Georgia.

35 (2)(A) Any part of the Richmond County School District which is not included in the
36 descriptions of School Board Districts 1 through 8 as described in paragraph (2) of
37 subsection (e) of this section shall be included within that district contiguous to such
38 part which contains the least population according to the United States decennial census
39 of 2020 for the State of Georgia.

40 (B) Any part of the Richmond County School District which is not included in the
41 descriptions of School Board Districts 9 and 10 as described in paragraph (2) of
42 subsection (e) of this section shall be included within that district contiguous to such

43 part which contains the least population according to the United States decennial census
44 of 2020 for the State of Georgia.

45 (3)(A) Any part of the Richmond County School District which is described in
46 paragraph (2) of subsection (e) of this section as being included in School Board
47 District 1, 2, 3, 4, 5, 6, 7, or 8 shall nevertheless not be included within such district if
48 such part is not contiguous to such district. Such noncontiguous part shall instead be
49 included within that district contiguous to such part which contains the least population
50 according to the United States decennial census of 2020 for the State of Georgia.

51 (B) Any part of the Richmond County School District which is described in
52 paragraph (2) of subsection (e) of this section as being included in School Board
53 District 9 or 10 shall nevertheless not be included within such district if such part is not
54 contiguous to such district. Such noncontiguous part shall instead be included within
55 that district contiguous to such part which contains the least population according to the
56 United States decennial census of 2020 for the State of Georgia."

SECTION 3.

58 (a) Those members of the Board of Education of Richmond County who are serving as such
59 on the effective date of this Act and any person selected to fill a vacancy in any such office
60 shall continue to serve as such members until the regular expiration of their respective terms
61 of office and upon the election and qualification of their respective successors.

62 (b) School Board Districts 1, 2, 3, 4, 5, 6, 7, 8, 9, and 10, as they exist immediately prior to
63 the effective date of this Act, shall continue to be designated as School Board Districts 1, 2,
64 3, 4, 5, 6, 7, 8, 9, and 10, respectively, but as newly described under this Act, and on and
65 after the effective date of this Act, such members of the board serving from those former
66 school board districts shall be deemed to be serving from and representing their respective
67 districts as newly described under this Act.

SECTION 4.

69 The provisions of this Act necessary to conduct elections for the members of the Board of
70 Education of Richmond County in 2022 shall become effective upon the approval of this Act
71 by the Governor or upon its becoming law without such approval. The remaining provisions
72 of this Act shall become effective on January 1, 2023.

SECTION 5.

74 All laws and parts of laws in conflict with this Act are repealed.
