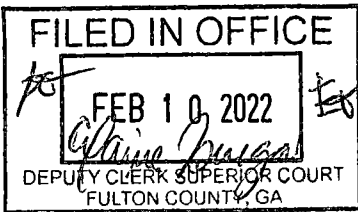

in the name and behalf of the citizens of Georgia, do charge and accuse **ROBIN FOLSOM** with the offense of **IDENTITY FRAUD**, in violation of **O.C.G.A. § 16-9-121(a)(4)** for the said accused, in the County of Fulton and State of Georgia, on about May 6, 2021, did willfully and fraudulently use fictitious identifying information, to wit: a name, concerning a fictitious person, to wit: Bran Otmembewe, with intent to use such fictitious identification information for the purpose to committing and facilitating the commission of a fraud on another person, to wit: Jennifer Statham and Georgia Vocational Rehabilitation Agency and the State of Georgia, contrary to the laws of said State, the good order, peace, and dignity thereof.

**COUNT 2**

and the Grand Jurors aforesaid, in the name and behalf of the citizens of Georgia, do charge and further accuse **ROBIN FOLSOM** with the offense of **FALSE STATEMENTS**, in violation of **O.C.G.A. § 16-10-20** for the said accused, in the County of Fulton and State of Georgia, on or about October 13, 2021, did knowingly and willfully make a false, fictitious and fraudulent statement, to wit: when asked by an investigator with the Office of the State Inspector General if Bran Otmembewe was a real person, said accused did answer "yes", in a matter within the jurisdiction of the Office of the State Inspector General, an agency of state government, contrary to the laws of said State, the good order, peace, and dignity thereof.

### COUNT 3

and the Grand Jurors aforesaid, in the name and behalf of the citizens of Georgia, do charge and further accuse **ROBIN FOLSOM** with the offense of **FALSE STATEMENTS**, in violation of **O.C.G.A. § 16-10-20** for the said accused, in the County of Fulton and State of Georgia, on or about October 12, 2021, did knowingly and willfully make a false, fictitious and fraudulent statement, to wit: said accused did state to an investigator with the Office of the State Inspector General that Liam Folsom was born at Piedmont, in a matter within the jurisdiction of the Office of the State Inspector General, an agency of state government, contrary to the laws of said State, the good order, peace, and dignity thereof.

### COUNT 4

and the Grand Jurors aforesaid, in the name and behalf of the citizens of Georgia, do charge and further accuse **ROBIN FOLSOM** with the offense of **FALSE STATEMENTS**, in violation of **O.C.G.A. § 16-10-20** for the said accused, in the County of Fulton and State of Georgia, on or about October 13, 2021, did knowingly and willfully make a false, fictitious and fraudulent statement, to wit: said accused did state to an investigator with the Office of the State Inspector General that Liam Folsom was born on July 25, 2020 and Ahmahli Folsom was born on May 1, 2021, in a matter within the jurisdiction of the Office of the State Inspector General, an agency of state government, contrary to the laws of said State, the good order, peace, and dignity thereof.
