

Re: October 2022 Financial Reports

Highlights for the General Fund revenues and expenditures are as follows:

- Property tax revenue have become to come in strong this month. Heavy collections normally occur October through January. We will collect the bulk of our revenue from this area during this time period.
- Local Option Sales Tax (LOST) Collections continue to outpace budgeted revenue for this area. Time will show how the economy may affect our future collections. Historically, Bulloch County has been somewhat insulated from larger downturns in economic conditions when compared to other parts of our state or country.
- State QBE revenues are being collected as they were budgeted.
- Expenditures in the General Fund were in line as they were budgeted. As of October 31, 2022, we have completed 33.34% of the fiscal year and our year-to-date expenditures are at 32.8% of total budget.

Old Business

Board Policy IEDA: Recess/Unstructured Break Time

Original Adopted Date: 01/13/2005 | Last Revised Date: 02/11/2016

Status: DRAFT

The Board allows the scheduling of unstructured break time for students in kindergarten through 8th grade:

The Board of Education requires each elementary school to schedule recess for all students in kindergarten and grades one through five every school day; provided, however, that recess shall not be required on any school day on which a student has had physical education or structured activity time or if reasonable circumstances impede such recess, such as inclement weather when no indoor space is available, assemblies or field trips exceeding their scheduled duration, conflicts occurring at the scheduled recess time over which the classroom teacher has no control, or emergencies, disasters, or acts of God.

The Board allows the scheduling of unstructured break time for students in grades 6 through 8 at the discretion of the school principal.

The school principal is authorized to determine the length, frequency, timing, and location of breaks at each school.

In determining the schedule for recess or unstructured break time for students, the principal shall consult with appropriate instructional personnel at the school and system level when necessary to ensure that break time does not interfere with academic learning. The principal shall also issue directions concerning the responsibility for supervision of students so that break time will be a safe experience for them.

Principals are responsible to provide a safe experience for all students and to have a supervision plan.

Breaks may be withheld from students for disciplinary or academic reasons if prior notice of such is given to the students, and their legal guardian as to when this might take place. The decision to withhold a break time will not be inconsistent with a-student any behavioral plan adopted developed by the school for the student, including a Section 504 Plan or an Individualized Education Plan.

Re: Extension of Closing Date for Old JPB Property

The land developer received notification in early November that he did receive the tax credits for developing senior housing on the site of our old JPB school. That was one of the contingencies of him purchasing the land from us. In our agreement, the closing date was set for no later than December 31, 2022. He is requesting that we grant an extension on the closing date to January 31, 2023. In consideration of us granting an extension, we have also asked him to remove all contingencies that were in the original contract. The attached amendment shows the removal of all contingencies and then the extension of the closing date to no later than January 31, 2023. We are asking the Board to approve this amendment.

SECOND AMENDMENT TO REAL PROPERTY PURCHASE AND SALE AGREEMENT

Pursuant to Section 13.4 of the Real Property Purchase and Sale Agreement entered into and executed by the Bulloch County School District (the "Seller") and Stockyard Housing, LP, a Georgia limited partnership (the "Buyer" and, with the Seller, the "Parties," and each individually, a "Party"). on March 25, 2021 (the "Agreement') as well as the Amendment to the "Agreement" executed May 3, 2022 and in consideration of the covenants, agreements, and premises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby execute and enter into this Second Amendment to Real Property Purchase and Sale Agreement ("Amendment") and amend the Agreement as follows:

Section 1.1 of the Agreement is hereby deleted in its entirety and replaced with the following:

1.1 Contemporaneously with the execution of a long-term ground lease for that portion of Bulloch County Tax Parcel No. MS38000056000 identified as "Parcel #1" in Exhibit A to this Agreement ("Phase 1") by the City of Statesboro, Georgia and the Buyer, or its successor-in-interest or assignee, which shall in no event occur later than January 31, 2023, Seller hereby agrees to sell and convey to Buyer, and Buyer hereby agrees to purchase from Seller, certain real property in Bulloch County, Georgia, comprised of a portion of Bulloch County Tax Parcel No. MS38000056000 and identified as "Parcel #2" in Exhibit A to this Agreement (the "Property"). The exact size, location, and legal description of the Property shall be determined in the manner set forth in Sections 4.2 and 4.3 of this Agreement.

And, the Parties hereby agree that this Second Amendment to Real Property Purchase and Sale Agreement does not extend the due diligence period set forth in Section 7.2 of the Agreement, and that the Due Diligence Period has already lapsed.

Additionally, as DCA has designated tax credits for the development of the Property, the contingency in Section 7.3 of the Agreement has been met and Buyer will execute Agreement.

Re: Purchase of Mobile Bathroom Units

We are requesting the purchase of two mobile bathroom units for next school year in order to address upcoming needs. One of the units will be placed at Brooklet Elementary and one of the units will be placed at Langston Chapel Elementary. We have solicited bids for thirty days via the Georgia Procurement Website and are recommending we award the bid to Modular Solutions.

We will be using these mobile bathroom units to support the classrooms that are housed in the mobile units at these two schools. When we purchased mobile classroom units over the past years, we did not purchase units that had bathrooms because of the additional space they would use in the classroom and due to the increased cost of the unit. These new bathroom mobile units will facilitate children and staff to stay closer to their classrooms instead of having to go inside the school building. In effect, we have created a wing of mobile classrooms and as we are expanding these outdoor mobile classroom wings, we are supporting it with bathroom facilities. The mobile bathroom units will be situated in a way so that they are close to the mobile classrooms. These units will be ordered now and will be installed and ready for use when school starts next year.

We are requesting that the Board purchase these two mobile units from Modular Solutions, who was the low bidder, in the total amount of \$208,400. In addition to this cost, we are requesting an additional 10% (\$20,840) be set aside as a contingency. The total of the base bid and the contingency will be \$229,240. These will be funded by ESPLOST IV. I have also attached the bid tabulation form.

The attached memo from Mr. Ryan Macy, Director of Facility Management, lays out two bids that were just evaluated in regards to the exterior stucco and gutter systems at three of our elementary schools (Mill Creek, Portal, and Brooklet). We have thoroughly evaluated these bids and are recommending the low bidder for each project. Mr. Macy has done an excellent job in laying out in plain english what both the purpose and scope of what we were needing to accomplish. Therefore, I will ask you to refer to his attached memo so as not to be redundant. These projects will be funded by ESPLOST IV. You will also find the bid tabulation forms attached.

RE: Exterior Insulation and Finish Systems Replacement and Repair

Exterior Insulation and Finish Systems (EIFS), sometimes referred to as synthetic stucco, is part of the building envelope systems found at many of our schools. EIFS is a part of the building cladding/facade that provides a weather barrier and thermal properties. When properly designed and installed, EIFS can be one of the best performing systems to provide thermal and moisture protection. EIFS is also one of the more economical cladding/facade systems in use today.

It was observed that the EIFS at some of our schools are showing signs of water damage. The damage ranges from staining to total system failure, including detachment from the studs/substrate to which it is attached. The Facilities Management Department retained the services of WM Building Envelope Consultants to extensively investigate the damage to the EIFS. The investigation revealed that water has penetrated the EIFS near the roof line and through gutter systems resulting in minor to significant damage.

For example, the EIFS at Mill Creek Elementary School cannot be repaired or preserved and total replacement is required, including new gutters and downspouts. Large sections of the EIFS at Mill Creek Elementary School have detached from the building exterior. At Brooklet Elementary School and Portal Elementary School, the EIFS requires relatively minor repairs to prevent more significant water damage and future complete system failure (similar to Mill Creek Elementary School). The gutter systems at both schools must also be replaced to prevent water from entering the building envelopes.

To address the damages discovered, project # WMBE 2022-106 was created and posted to the Georgia Procurement Registry on October 4, 2022 and was advertised until November 3, 2022. It was also posted on the Bulloch County School System website. The scope of the project base bid includes removal of the existing EIFS down to the metal studs and total replacement at Mill Creek Elementary School. Metal flashings and a fluid applied waterproofing membrane will be incorporated into the system to prevent water from penetrating. New gutters and downspouts will be installed to replace the current gutter systems that are permitting water to penetrate the building envelope system.

Included in Project # WMBE2022-106 were three alternates. Alternate #1 includes repairs to the existing EIFS, a fluid applied waterproofing membrane, flashings, and new gutters and downspouts at Portal Elementary School. Alternate #2 includes repairs to the existing EIFS, a fluid applied waterproofing membrane, flashings, and new gutters and downspouts at Brooklet Elementary School. Alternate #3 includes replacement of exterior sealants around doors and windows not in contact with the EIFS at Mill Creek Elementary School.

Project # WMBE 022-107 was posted to the Georgia Procurement Registry on October 22, 2022 and was advertised until December 1, 2022. It was also posted on the Bulloch County School System website. This project included a duplicate posting of Alternate #1 and Alternate #2 included in project# 2022-106 above to seek the best competitive pricing for Bulloch County Schools.

The base bid includes repairs to the existing EIFS, a fluid applied waterproofing membrane, flashings, and new gutters and downspouts at Portal Elementary School. Alternate #1 includes repairs to the

existing EIFS, a fluid applied waterproofing membrane, flashings, and new gutters and downspouts at Brooklet Elementary School. Alternate # 2 includes replacement of exterior sealants around doors and windows not in contact with the EIFS at Portal Elementary School and Brooklet Elementary School

Written, sealed bids for project # WMBE 2022-106 were opened publically on November 3, 2022 at 2:00 PM. It is my recommendation that Hubbard and Hudson Construction, LLC, the lowest responsive bidder, be selected to complete the base bid work at Mill Creek Elementary School for the sum of \$965,000, as well as Alternate #3 (sealants) for \$15,800. The total project cost is \$980,800.00. I do not recommend accepting Alternate #1 (work at Portal Elementary School) or Alternate #2 (work at Brooklet Elementary School). Bidding these alternates as a separate project recognized cost savings. Please see below (project # WMBE 2022-107).

Written, sealed bids for project # WMBE 2022-107 were opened publically on December 1, 2022 at 2:00 PM. It is my recommendation that Ketom Construction Company, Inc., also the lowest responsive bidder, be selected to complete the base bid work at Portal Elementary School for the sum of \$298,104.00, Alternate#1 (Brooklet Elementary School) for the sum of \$306,185.00, and Alternate #2 (sealants at Portal Elementary School and Brooklet Elementary School) for the sum of \$8,585.00. The total project cost is \$612, 874.00.





With the passage of ESPLOST V that was on the November 8, 2022 ballot, the Board must take action to approve a resolution declaring the results of said election. The resolution is attached and we are asking the Board to approve the signing of such resolution.

RESOLUTION OF THE BOARD OF EDUCATION OF BULLOCH COUNTY DECLARING THE RESULTS OF AN ELECTION HELD ON NOVEMBER 8, 2022 AND CERTIFICATE OF ELECTION SUPERINTENDENT

WHEREAS, the Board of Education of Bulloch County (the "Board of Education"), acting by, for, and on behalf of the Bulloch County School District (the "School District"), adopted a resolution on July 19, 2022, to reimpose, levy, and collect a one percent sales and use tax for educational purposes within the School District and to authorize the imposition of general obligation bonded debt and the issuance of general obligation bonds of the School District, conditioned upon approval by a majority of the qualified voters residing within Bulloch County (the "County") voting in a referendum thereon to be held on November 8, 2022; and

WHEREAS, a copy of said resolution was delivered to the Bulloch County Board of Elections, as Election Superintendent for Bulloch County (the "Election Superintendent"), who issued a call for the election described in said resolution; and

WHEREAS, the Election Superintendent caused notice of said election to be published in the newspaper published in the County in which sheriff's advertisements for the County are published, notifying the qualified voters of the County that on November 8, 2022, an election would be held (the "Election"), said notice having been published for the time and in the manner and containing the specifications and information required by law; and

WHEREAS, the Election was held on November 8, 2022, in accordance with said resolution, call, and notice, and the several managers of the Election brought in the returns from the Election as required by law and these officers calling the Election, in the presence of and together with the several managers, consolidated the returns and the results thereof; and

WHEREAS, the consolidated returns found the results of the Election to be as follows:

1% EDUCATIONAL SALES TAX

Shall a one percent sales and use tax for educational purposes continue to be imposed in the Bulloch County School District for a period of time not to exceed five years and for the raising of not more than \$110,000,000 for the purposes of (A) the acquisition, construction, and equipping of a new Southeast Bulloch High School, and (B) funding the following capital outlay projects for educational purposes at Brooklet Elementary School, Julia Bryant Elementary School, Langston Elementary School, Langston Chapel Middle School, Mattie Lively Elementary School, Mill Creek Elementary School, Nevils Elementary School, Portal Elementary School, Portal Middle/High School, Sallie Zetterower Elementary School, Southeast Bulloch High School, Southeast Bulloch Middle School, Statesboro High School, Stilson Elementary School, Transitions Learning Center, William James Complex, William James Middle

School, the Central Office, the Transportation Department, the Maintenance Department, and Bulloch County School Auxiliary Services, and any other property owned by the school district:

(i) Safety and Security

to include, but not be limited to equipment and software, i.e., cameras, radios, lighting, fencing, fire suppression, security walls and glass, intercoms, bells, clocks, entry systems, networking, etc.;

(ii) Instructional and Technology Resources

to include textbooks and other related materials; digital resources to include eBooks, subscriptions, etc.; software to include but not be limited to license agreements, purchased software, or cloud based applications; and digital resource platforms to include but not be limited to license agreements, purchased platforms, or cloud based application; technology hardware and other devices;

(iii) Buildings and Land

to include physical education (PE) and athletic facility improvements, renovations and additions; renovations, building and land improvements, and new construction to include but not be limited to roofing, plumbing, electrical, lighting, wiring, fiber, painting, water piping, HVAC, renovations necessary to comply with the Americans with Disabilities Act (ADA), energy management systems, repaving, and railings; purchase of land for current or future use; site work and associated costs; and

(iv) Equipment and Vehicles

to include playground equipment, relocation, and refurbishments and all related costs; buses and other vehicles; equipment, furniture and furnishings, copiers, and other office equipment?

If imposition of the tax is approved by the voters, such vote shall also constitute approval of the issuance of general obligation debt of the Bulloch County School District in the principal amount of \$80,000,000 for the above capital outlay purposes and for the payment of capitalized interest.

WHEREAS, a copy of the Election Summary Report and Consolidated Returns filed by the Election Superintendent with the office of the Secretary of State and the Commissioner of the Georgia Department of Revenue is attached hereto and made a part hereof as Exhibit A; and

WHEREAS, a majority of the qualified voters of the County voting in the Election voted in favor of the question which gives approval for the reimposition of the one percent sales and use tax for educational purposes and the issuance of general obligation debt of the School District in the principal amount of \$80,000,000.

NOW, THEREFORE, BE IT RESOLVED AND CERTIFIED AS FOLLOWS:

- 1. To the extent that the Board of Education may be considered as one of the officers ordering the Election under the provisions of Official Code of Georgia Annotated § 38-82-2, or any other provisions of law which may be deemed applicable, the Board of Education does hereby declare the results of the Election to be in favor of both questions set forth above, which constitutes approval of the reimposition of the one percent sales and use tax for educational purposes and of the issuance of general obligation debt of the School District in the principal amount of \$80,000,000.
- 2. The consolidated returns of the Election and this resolution shall be entered upon the minutes of this meeting of the Board of Education.
- 3. The Election Superintendent has prepared copies of the consolidated returns and certified and filed the same as required by law. The Election Superintendent has complied with all other applicable provisions of the Georgia Election Code.
- 4. The issuance of general obligation debt having been duly approved, ratified and confirmed, statutory notice to that effect shall be served upon the District Attorney of the Ogeechee Judicial Circuit of Georgia, and such notice shall be executed on behalf of the Board of Education by its Chairman so that said District Attorney may, as provided by law, institute proceedings to have such general obligation debt validated.
