





I went up to the store to get gas and other items for myself. I immediately called Irene back to see and assess the situation. Irene was shaken and scared Seeing her discomfort I dropped what I was doing and came immediately home. Upon My arrival and entering My appartment Trene and My son Angellafust in age rushed to me to tell me what happened. Some kids in our complex were knocking on the door and running away from it as a prank of some sorts. Kids being kids. Irene apened the door to see whom was knocking and Bean our husky tried getting out. She was able to grab him buck in. Just as she had done that

hodak ran up and grab Bean by the throat and assumed his aftack on him. Brandon Mor-Payton Raglands boyfriend rushed down to the situation to grab Kodak. Payton Ragland never put kodak on a lesh the entire time of Me living here since April 1, 2024. He was always allowed to roam around the complex freely while others like us dog owners, leshed our dogs. There had also been sever! times whom "" sever! Firmes where Kodak would aggressively chase my upstain neighbors either on the top of their our or back into their apportment when all they were trying to do was exit or enter their home. Due to Kodak being the way he was several times to My dogs I had to limit the access of when and where my dogs where able to go out to be able to use the both to to use the bathroom. On several or occasions I had to let my dogs out on the porch to use the bathroom because I didn't know if Kodak was out. And when

he was he let it known by trying to attack my dogs through our pourch railings. Several times neighbors across from me helped me break up the dogs after Kodak whould try attacking My dogs. I was patient with Payton lagland as she expressed to my several times she was going to get him fixed. I was understanding being that yes kodak was here first in this complex and my dogs were new in his territory. dogs were new in this territory. One day about 2 months before oul this I was just home from work and had to take my dogs out. I had to do it one by one to make sure I could control my clogs. I took my other husky Demon out on his lesh not knowing that Kodak was out roaming. I was in the Middle of the two buildings in the grassy area of My complex. This is an area where everyone takes their day to use the bathroom. Along with a few other areas in this complex.

Demon had urinated and was by a bush. I was walking him round a bit once more before taking him in. I looked up and saw kadak with no tesh and no owner around. He started to grow! and ran up to Demon faster than I could run with him back to my apartment. He lunged at often Demon attacking him. I had Demon on his lest so I row remon on his rest so

I finally sent a message to Payten and to Rachel about the incidences stating I had done everything I could do on my end and that if it happened egain I would be contecting animal control. On the night of the attack with an officer from the Shiriff department. came to my door after trying to get in contect with animal contract Control. He asked about a dog attacking some one. We told him that kadak attacked a dog from our knowledge. Just after that the young man from upstairs awas out on his balcony saying he called About the dog attacking him.

The deputy listend to mine and my sisters statement then listend to the young mans stertement. Terry from animal Control finally arrived and got both parties statements. Then Terry asked if anyone of us had a contact number, for Payton. I told him I had that information and that just before she left that I told her Payton not to leave because the Police and animal control were on the way. She still left leaving Brandon Mort upstairs in their apartment with Kodak. Terry tried contacting Payton by calling and texting Payton and Rachel Ragla of the Situation and niether came back or showed up. The officer and Terry both went to the dour and knocked several times anouncing their selves selfs. Neighburs across from 'us told us and the officer that Brandon was in fact in the apartmen as they could see him passing by the cloths hanging on the balcony of the apartment. He never answered the

door though. Terry and the officer let me know that they are would have to come back the following day to handle situation in a legal manner. 9/24/2024 I was at work and at 2:14 pm I recieved a long message from Payton that was very unnecessary with some name calling and denile of her neglagance. I simply told her that her lack of accountibilty in the situation was accountibilty in the situation was felt. I went nome to only find that my dog Bean was howing involentary movements and not outing as he normally does. We were concerned and called animal curtral to ask if theire was any update on the other dogas for as if he had been picked up or had rabies. A lady at the shelter said Terry was going to contact us. Terry then called and said he masn't Sure of the rabies but was at the complex earlier and did see Kodak out without a losh or owner and took

him to the smelter. He told me to get our dog to the vet as soon as possible and that I did I went to the Northwest Emergency Pet Clinic in Rome GA at 5pm for them to tell me now that Bean had a purcture wound on his neck and ear and was most likly setting up in fection. So they sent us home with antibiotics to take care of the infection from the attack mode by Kodak. The following day their were lies about the whole situation on Facebook by Payton Ragland saying that I paid off the Animal Shelter to Kill Kodak. That's not true as I had before on 9/22/2024 My readels bank account comprimized by a skimmer and had to a fraud case started for the negative obalance of -\$8900. As a dog laver myself I would never do something like that. That why I tried so hard to prevent all this from happening. I know and understand the consequences of not leshing your dog. And to stop the threats twords Me from Payton.

CHATTOOGA COUNTY ANIMAL CONTROL ORDINANCE

Section 1. Definitions

The following words, terms and phrases, when used in this ordinance, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Domesticated animal means any animal raised so as to live in close proximity to humans. Such animals include dogs, cats, poultry, livestock or reptiles.

Domesticated animal at large means any domesticated animal not under the restraint of a person capable of controlling it on or off the premises of the owner.

Exotic animal means any live alligator, crocodile, canine, fox, bear, sea mammal, poisonous snake, member of the feline species other than domestic cat (felis domesticus), member of the canine species other than domestic dog (canus familiaris) or any other animal that would require a standard of care and control greater than that required for customary domestic animals or household pets sold by commercial pet shops, or required for traditional farm animals. Exotic animal also means those animals as defined in Chapter 5 of Title 27 of the Official Code of Georgia Annotated.

Wild animal means any live monkey, nonhuman primate, raccoon, skunk, fox, leopard, panther, tiger, lion, lynx or any other warm blooded animal that can normally be found in the wild state. The term "wild animal" does not include: domestic dogs (excluding hybrids with wolves, coyotes or jackals), domestic cats (excluding hybrids with ocelots or margays), farm animals, rodents, any hybrid animal that is part wild, a captive breed species of common cage birds. Wild animals shall also mean those animals as defined in Chapter 5 of Title 27 of the Official Code of

Georgia Annotated.

Wild carnivore means any meat eating wild animal (as defined above) including, but not limited to, members of any species in the order carnivora, the order primates, or the class reptilia, if the species eats meat as a part of a normal diet.

Owner means any person who owns, possesses, harbors or keeps or knowingly permits an animal to be harbored or kept or has an animal in his care or who permits an animal to remain on or about his premises for more than three days.

Public nuisance means any animal that unreasonably annoys humans, endangers the life or health of other animals or persons or substantially interferes with the rights of citizens other than its owner to enjoyment of life or property. The term "public nuisance" means and includes, but is not limited to any animal that:

- (1) Is found at large;
- (2) Damages the property of anyone other than its owner;
- (3) Chases vehicles;
- (4) Attacks other domestic animals;
- (5) Unprovoked, attacks pedestrians or passersby;
- (6) Has been found by the animal control officer to be a public nuisance animal by virtue of being a menace to the public health, welfare, or safety;
- (7) Habitually barks, howls, crows, or makes any other loud noises in such a way as to at any time, day or night causes, annoyance or discomfort to people living in the neighborhood;
- (8) Soils, defiles or defecates on public or private property other than the property of the owner/keeper unless it is immediately removed and properly disposed of by the

owner/keeper.

Vaccination means a protection against rabies by inoculation with anti-rabies vaccine given in an amount sufficient to provide immunity from rabies for a minimum of one year.

Section 2. Animal Control Officer

- (a) There is created the office of animal control officer which officer shall enforce this ordinance. The county may at any time and from time to time contract or enter into an agreement with any other municipality, county or combination thereof for staffing the position of animal control officer.
- (b) The animal control officer is authorized to issue citations to persons violating this ordinance for trial in the Magistrate Court of Chattooga County upon such citations.
- (c) The animal control officer, as well as employees and agents of the animal control officer and persons under his control and supervision are empowered to seize animals as required by this ordinance so long as the animals are within the unincorporated areas of the county. The employees and agents of the animal control officer and persons under his control and supervision shall have the right to go on private property within the unincorporated areas of the county for the purposes of enforcing this ordinance provided it is necessary for such purpose.

Section 3. Magistrate Court Jurisdiction

The Magistrate Court of the county shall have jurisdiction over all alleged violations of this ordinance.

The following persons have standing to file complaints for violations of this article:

- (1) The animal control officer or his agent;
- (2) Other law enforcement officers;
- (3) Public health officials;

Section 4. Unlawful Interference by Third Parties

- (a) No person within the unincorporated areas of the county shall, without the knowledge or consent of the owner, hold or retain possession of any animal that he does not own for more than seventy-two hours without first reporting the possession of such animal to the animal control officer. This subsection shall not apply to those nonprofit organizations whose purpose is protection of animals.
- (b) No person within the unincorporated areas of the county shall willfully cause an animal to be in violation of any section of this ordinance.
- (c) It shall be unlawful for any person within the unincorporated areas of the county to attack, assault, or in any way physically or verbally threaten or interfere with the animal control officer or his agents in the performance of those duties required to enforce this ordinance.
- (d) It shall be unlawful to tamper with, destroy or take any trap which has been set by the animal control officer or his agents.

Section 5. Vaccinations

All dogs and cats within the unincorporated areas of the county must be vaccinated against rabies with the vaccine and in the manner prescribed by the state veterinarian and the state board of health. Vaccinated dogs and cats shall be provided with the proper tag. The owner of every dog or cat vaccinated shall obtain from a veterinarian a certificate of such information.

Section 6. Prohibited Activities

- (a) Generally. The following activities shall be prohibited and the owner shall be subject to the issuance of a warning from the animal control officer upon the first offense; a person who commits a subsequent offense shall be punished pursuant to Section 9 of this ordinance:
 - (1) Animals running at large. It is unlawful for any owner to cause or allow an animal to

- run at large in or on any public property, vacant lot or private property within the unincorporated area of the county without the consent of the property owner.
- Animals disturbing the peace. It is unlawful for any person to allow any animal in his possession or control within the county to persistently or continuously bark, howl, or make noise common to its species or otherwise to disturb the peace and quiet of the surrounding neighborhood. It shall likewise be unlawful to keep or maintain any such animal in such a manner as to produce obnoxious or offensive odors or to otherwise endanger the health and welfare of the surrounding inhabitants.
- (3) Dog control. No person owning or otherwise having a dog in his care, charge, control, custody or possession within the unincorporated areas of the county shall cause, permit or allow such dog to be in or upon any public area unless such dog is under restraint by leash or chain. The leash or chain shall not exceed six feet in length.
- (4) Cat control. No person owning or otherwise having a cat in his care, charge, control, custody or possession within the unincorporated areas of the county shall cause, permit or allow such cat to be in or upon any public area unless such cat is physically restrained.
- (5) Keeping of sick or diseased animals. It is unlawful for any person within the county to own any animal that is seriously sick or injured and that is not provided with proper veterinary care. This subsection shall not be construed to include animals under active veterinary care or in veterinary hospitals.
- (6) Shelter requirements. Animals within the unincorporated areas of the county shall be confined only within an enclosed fence area of sufficient height to contain said

animal. Animals confined by fence shall be provided shelter which shall meet the following minimum requirements:

- (a) The housing facility shall be structurally sound and maintained in good repair to protect the animal from injury and to contain the animal.
- (b) Enclosures shall be constructed and maintained to provide sufficient space to allow each animal adequate freedom of movement.
- (c) Minimum standards of sanitation necessary to provide humanly clean conditions for both indoor and outdoor enclosures shall include periodic cleaning to remove excretions and other waste materials, dirt and trash to minimize health hazards.
- (d) When sunlight is likely to cause heat exhaustion of an outside animal, sufficient shade by natural or artificial means shall be provided to protect the animal from direct sunlight.
- (7) Keeping of farm or game animals. It shall be unlawful for any person to keep or maintain livestock including, but not limited to, fowl, goats, pigs, cattle, mules, horses, sheep, swine, or any other farm or game animal in the county except as follows:
 - (a) Larger than ten (10) acres. On any property that is larger than ten acres, there are no restrictions in this ordinance as to the number of livestock that may be kept. Other applicable provisions as to type, adequate shelter, humane care, and so forth, must be obeyed.
 - (b) Larger than two (2) acres, but equal to or less than ten (10) acres. On property that is larger than two acres, but equal to or less than ten acres,

limited numbers of livestock animals are permitted. No more than eight (8) livestock animals total shall be permitted on property in this size range or no more than twenty (20) chickens; if both chickens and other livestock animals are kept, no more than eight animals total shall be permitted. Further, either a single chicken coup, or a single minor livestock enclosure for up to eight animals may be erected for housing livestock, but not both.

(c) Equal to or less than two (2) acres. On any property that is equal to or less than two acres, it shall be unlawful to possess or keep any livestock.

In addition, all feed lots, poultry facilities and other livestock confinement facilities or structures designed to or capable of housing or confining more than one hundred (100) animals or birds shall have a setback of at least five hundred (500) feet from any property line and a setback of at least one thousand five hundred (1500) feet from any preexisting residence. For poultry facilities, the rules set forth in the previous ordinance of this County shall prevail.

- (8) Cruelty. It shall be unlawful to abandon any animal or fail to provide it with sufficient wholesome and nutritious food and water in sufficient quantities, proper air, shelter, space and protection from the weather. No person shall beat, cruelly treat, torment, or otherwise abuse an animal.
- (9) Animal fights. It is unlawful for any person to promote, stage, hold, manage, conduct, carry on, train for, attend or own any animal for the purpose of participating in any game, exhibition, contest or fight in which one or more animals are engaged for the purpose of injuring, killing, maining or destroying themselves or any other animal.

- (10) Female dogs or cats in heat. It shall be unlawful for the owner of any female dog or cat to allow the animal to run at large while in heat.
- (11) Vaccination. All dogs and cats shall have proper tags evidencing vaccinations as provided in Section 5 of this ordinance.
- (12) Destruction of property. No animal shall destroy or damage private or public property.

Section 7. Impoundment

- (a) Any animal seized and impounded under any of the sections of this ordinance shall be detained for a period of five business days. If the ownership of the animal is not determined within that period the animal shall be disposed of in such a manner as the animal control officer may designate. Any animal seized that is wearing identification tags shall be kept for ten days and then the animal control officer shall attempt to notify the owner by writing or phone if possible.
- (b) If at any time during the required waiting period set forth in subsection (a) of this section, the owner indicates to the animal control officer his intention to not reclaim the animal the balance of the waiting period shall be waived and the animal shall be disposed of pursuant to this section.
- (c) If at any time during the required waiting period examination of the animal by the animal control officer indicates the animal to be severely sick and or to be a threat to the health or other animals detained in the impoundment the balance of the waiting period shall be waived and the animal shall be disposed of pursuant to this section.
- (d) Nothing in this section shall prevent the animal control officer from euthanizing an animal when he determines that it is a menace to the public safety or to other animals and can not be impounded with reasonable effort.

Section 8. Number of Animals

- (a) Dogs. The following restrictions apply to the maximum number of dogs that may be possessed or kept on property or premises:
 - (1) Larger than two (2) acres. On any residential property that is larger than two acres, there shall be no restriction on the number of dogs allowed to be possessed or kept, provided all other applicable provisions of this Ordinance are obeyed, however, any such property that contains more than six (6) dogs shall be required to maintain those animals in an enclosure at least one hundred feet from the nearest property line.
 - (2) Larger than one (1) acre, but equal to or less than two (2) acres. On any residential property that is larger than one acre, but equal to or less than two acres, it shall be unlawful to possess or keep more than six dogs.
 - (3) Equal to or less than one (1) acre. On any residential property that is equal to or less than one acre, it shall be unlawful to possess of keep more than three (3) dogs.
 - (4) Multi family units. For any dwelling unit in a multifamily development (e.g., apartment, condominium, town home, mobile home parks, duplex, triplex, quadroplex or similar) it shall be unlawful to possess or keep more than three (3) dogs. The overall acreage of the development or property shall not control.
- (b) Cats. The following restrictions apply to the maximum number of cats that may be possessed or kept on property or premises, based on the area of the lot. Other applicable regulations shall still apply and should be consulted for restrictions on location of shelters and enclosures and other restrictions.
 - (1) Larger than two (2) acres. On any residential property that is larger than two acres, there shall be no restriction on the number of cats permitted, provided all other applicable provisions of this Ordinance are obeyed.

- (2) Equal to or less than two (2) acres. On any residential property that is equal to or less than two acres, it shall be unlawful to possess or keep more than six cats:
- (3) Multi family units. For any dwelling unit in a multifamily development (e.g., apartment, condominium, town home, mobile home parks, duplex, triplex, quadroplex or similar) it shall be unlawful to possess or keep more than six (6) cats.

 The overall acreage of the development or property shall not control.
- (c) Other provisions. The limits on dogs and cats are independent. For example, a 1.5 acre parcel would allow up to six dogs and up to six cats. For litters of offspring, see Section 9.

Section 9. Animal Breeding; Pet Dealers

- (a) Breeding restrictions. It shall be unlawful for any person to breed animals on any property or premises except as specifically permitted in this ordinance. However, it shall be permissible for any household to have one litter per year (total, not per animal). In instances where a new litter causes a violation of Section 8, the new litter shall be exempt from the provisions of Section 8 for up to twelve (12) weeks from the date of birth. Any more than one litter per household, per year, shall make such person a pet dealer.
- (b) Livestock breeding restrictions. Persons breeding livestock shall comply with applicable state regulations and laws.
- (c) Operations requiring licensing. It shall be unlawful for any person to act as a pet dealer or private animal shelter unless such person has a valid license issued by the Georgia Department of Agriculture, pursuant to O.C.G.A. § 4-11-1 et seq and applicable state regulations.
- (d) Care of operations. It shall be unlawful to fail to keep the pet dealership premises, breeding operation or animal shelter in a good state of repair, in a clean sanitary condition, adequately ventilated, or disinfected when needed.

(e) Impoundment of animals from unlicensed operations. Animals kept by or at any unlicensed pet dealer or private animal shelter are subject to immediate impoundment at the owners expense.

Section 10. Conflict With Other Ordinances

To the extent any provision of this ordinance conflicts with any provision of an applicable ordinance or any other ordinance, statute or law, the stricter requirement shall control.

Section 11. Keeping of Exotic or Wild Animals

- (a) Exotic or wild animals unlawful. It shall be unlawful for anyone to own, harbor or permit at large any exotic animal or wild animal within the incorporated areas of Chattooga County without the written permission of the director of animal control who may impose upon the owner reasonable conditions of confinement to assure the protection and safety of the general public. Such conditions shall be imposed pursuant to and in relation to the threat posed by the species to other animals and to humans from attacks, bites, disease, nuisance, noise, order, or any similar harm. If a questions arises as to the status of an animal as domestic or exotic, the animal control director shall make the determination.
- (b) Wild carnivore is not permitted. No wild carnivores (including, but not limited to, tigers, chetahs, pumas, leopards, jaguars, lynx, bobcats, mountain lions, wolves, foxes, bears, raccoons, weasels, badgers, skunks, mongooses and hyenas shall not be kept as pets nor for any other purpose in Chattooga County.

Section 12. Repealer

Upon its effective date, any ordinance or parts of an ordinance contradictory to the provisions of this Ordinance are repealed.

Section 13. Penalty

Any person violating any provision of this ordinance, upon conviction, shall be subject to a fine of not less than \$250.00 nor more than \$1,000.00 and, in addition, may be imprisoned for a period of up to sixty days.

Bean has some minor wounds from the dog fight. He does not have any neurologic deficits at this time. One of the wounds (the one on the left side of the neck) has a little swelling and a bit of drainage, so I do have concerns about this developing an abscess. Recommend antibiotics, monitor closely over next few days, keep area clean/dry, warm compress to encourage drainage. Since the dog that bit Bean has unknown rables status, Bean is unvaccinated, and we are waiting results from animal control, Bean should be quarantined at a vet clinic at least until those results come back. O states that this is not doable for her due to her work schedule.



Please follow the administration of all tablets or capsules with a small amount of water so the medication does not get stuck in the patient's throat. As a general rule whenever medication is dispensed, only a few days supply is given, even if a longer course of therapy is needed. The reason for this policy is for you to contact your primary care veterinarian to let him/her know how your pet is progressing with therapy. Your primary care veterinarian can decide if your pet needs to be rechecked and if medication needs to be changed/stopped and/or refilied. This will assure your pet gets the proper care.


- (a) Any animal seized and impounded under any of the sections of this ordinance shall be detained for a period of five business days. If the ownership of the animal is not determined within that period the animal shall be disposed of in such a manner as the animal control officer may designate. Any animal seized that is wearing identification tags shall be kept for ten days and then the animal control officer shall attempt to notify the owner by writing or phone if possible.
- (b) If at any time during the required waiting period set forth in subsection (a) of this section, the owner indicates to the animal control officer his intention to not reclaim the animal the balance of the waiting period shall be waived and the animal shall be disposed of pursuant to this section.
- (c) If at any time during the required waiting period examination of the animal by the animal control officer indicates the animal to be severely sick and or to be a threat to the health or other animals detained in the impoundment the balance of the waiting period shall be waived and the animal shall be disposed of pursuant to this section.
- (d) Nothing in this section shall prevent the animal control officer from euthanizing an animal when he determines that it is a menace to the public safety or to other animals and can not be impounded with reasonable effort.
