WHEREAS, the Board of Elections and Registration of Chattooga County (hereinafter referred to as the "Board") was created pursuant to House Bill 1063 enacted by the General Assembly of Georgia during the 2024 Session (hereinafter referred to as the "Act"); and

WHEREAS, the Act became effective on January 1, 2025; and

WHEREAS, the Republican Party is the political party having received the largest number of votes in the State of Georgia at the last regular general election held for the election of all members of the General Assembly; and

WHEREAS, the Democratic Party is the political party having received the second largest number of votes in the State of Georgia at the last regular general election held for the election of all members of the General Assembly; and

WHEREAS, the chairperson of the Chattooga County Republican Party nominated the following individuals for consideration by Chattooga County in fulfilling appointments to the Board on December 2, 2024: Betty Brady, Gartrelle Davison, John Agnew and Nick Casey; and WHEREAS, the chairperson of the Chattooga County Republican Party nominated the following additional individuals on January 3, 2025: Jennifer Tudor and Blake Elsberry; and

WHEREAS, the chairperson of the Chattooga County Democratic has nominated the following individuals for consideration by Chattooga County in fulfilling appointments to the Board on November 19, 2024: Alfred McDaniel, Brandon Gurley and Tim Shiflett; and

WHEREAS, the Act provides that the Chattooga County Commissioner, acting as the governing body of Chattooga County, (hereinafter referred to as the "Commissioner"), shall select two persons from the nominations provided by the chairperson of the Chattooga County Republican Party and two persons from the nominations provided by the chairperson of the Chattooga County Democratic Party for appointment to the Board; and

WHEREAS, the Act further provides that the Commissioner shall also appoint a person of the Commissioner's choice, and regardless of political affiliation, to serve as the chairperson of the Board.

NOW THEREFORE, pursuant to the Act, Chattooga County, Georgia, acting by and through its Commissioner, hereby appoints as members to the Board the following residents of Chattooga County:

- 1. Alfred McDaniel, who resides at 1018 McDaniel Road, Lyerly, GA 30730;
- 2. Brandon Gurley, who resides at 4427 Highway 27, Summerville, GA 30747;
- 3. John Agnew, who resides at 225 Red Horse Road, Summerville, GA 30747;
- 4. Gartrelle Davison, who resides at 14370 Highway 27, Apt. C150, Trion, Georgia 30753; and
- 5. Patricia Brison, who resides at 10711 Highway 100, Lyerly, GA 30730 as the Board's Chairperson.

It is further resolved that Alfred McDaniel and John Agnew shall serve an initial term of two years as provided by the Act.

It is further resolved that this Resolution shall be transmitted to the Clerk of the Superior Court of Chattooga County, Georgia.
